General condition

- a. The contactor shall inspect the site and fully acquaint himself with the condition with regard to accessibility of the site and site nature and the extent of ground, working conditions including stocking of martial, installation and T & P, etc, and conditions affecting accommodation and movement of labor, etc required for the satisfactory execution of the contact. No claim whatsoever on such account shall be entertained by the BSNL in any circumstance.
- b. The workers engaged by the firm should maintain proper discipline and good behavior. The firm shall remove such workers whose behavior is found improper from the site.
- c. The work shall be carried out as per Departmental Specifications. In all electrical installation works, relevant safety codes of practices shall be followed
- d. Any damage/theft to the EMS installation during the period due to carelessness shall be the responsibility of the firm and be replaced/rectified without any extra cost.
- e. Any accident will be the responsibility of the agency and the department will not entertain any claim, compensation, penalty, etc. on this account or on account of non-observance of any other requirement of law relevant to his work.
- f. In case of any fault/ damage in the EMS, it is the responsibility of the firm to intimate the Engineer- In charge within the reasonable time.
- g. Agency has to observe all the labor rules and regulations in force.
