Details of Notice Inviting for e-Tender

E-Tender is invited by the Chief General Manager, Chhattisgarh Telecom Circle, BSNL, Raipur on behalf of Bharat Sanchar Nigam Limited for printing and supply of Marketing Material from the eligible bidders. Details of tender are as under:

The official copy of tender document for participating in E-tender shall be available for downloading from Central Public Procurement Portal URL <https://etenders.gov.in/> from 28.01.2023 at 17:00 Hrs onwards.

2.1 The bidders downloading the tender document are required to submit the tender fee (along with applicable GST) amount through DD/ Banker’s cheque of Rs. 590/- along with their tender bid, failing which the tender bid shall be left archived unopened/ rejected.

The DD/ banker’s cheque shall be drawn from any Nationalized/ Scheduled Bank in favour of AO (A&B) BSNL O/o CGMT CG Circle Raipur, payable at Raipur.

2.2 The e-tender documents shall be issued free of cost to MSE bidders on production of requisite proof in respect of valid certification from MSME for the tendered item.

3.0 **Availability of Tender Document:** The tender document shall be available for downloading from 28.01.2023 from 17:00 Hrs onwards up to 15:00 Hrs on 17.02.2023. As the tender is invited through E-tendering process, physical copy of tender document would not be available for sale.

4. Bidder Eligibility (ONLINE SUBMISSION):

4.1 Certificate of Firm registration;

4.2 Bidder should have requisite experience to carry out similar work of printing in any one year during the last two financial years i.e. 2020-21 or 2021-22 from BSNL/MTNL/DOT/Central/State Govt./ PSU/Other Telecom operators for cost Rs. 2,00,000/- (Two Lakhs) .

- Experience Certificate of successful work done should be submitted as a proof.
- 4.3 Valid GST Registration Certificate.

 - 4.5 Certificate of minimum turnover of Rs 3 Lakhs per annum for last two financial years 2020-21 and 2021-22.
 - 4.6 Self declaration regarding no near relative working in BSNL.
 - 4.7 Undertaking for non black listing of the firm/company.
 - 4.8 Bid form section 07 duly signed.
 - 4.9 Certificate of not debarred /black listed in BSNL on a NON JUDICIAL stamp paper.
 - 4.10 Clause by clause compliance.

Tender which is not accompanied by the requisite bid security, eligibility conditions and terms & conditions of the tender above, shall liable to be rejected. E-Tender will not be accepted/received after last Date and Time of submission of Bid. The CGMT, CG Telecom Circle, Raipur reserves the right to reject any or all tenders without assigning any reason what so ever.

Bid Form should be downloaded from Website only and offline submission of DD of Rs.590/- as cost of document in favor of AO (A & B) O/o CGMT Raipur and the same (DD) should be submit offline along with offline documents in an Envelope in Tender Box. **The free bid document will be issued to Micro, Small and Medium Enterprises registered with NSIC in case their monitory limit is equal or more than estimated cost of tender, for getting free tender document notarized copy of NSIC mentioning the monitory limit and name of item should be furnished.**
