## Section-1

#### **GUIDELINES, TERMS & CONDITIONS FOR REGISTRATION AS A SUPPLIER**

For participating in BSNL tendering towards supply of goods or services, it is essential for the vendors to get themselves registered. The Notice Inviting Tender (NIT) documents shall be issued only to the vendors registered for the category for which NIT is issued. Mere registering as a vendor does not entitle the registered entity towards any claim for award of work/purchase order.

- 1. Vendors must submit all necessary information / documents in support of their qualification for registration as per the "Vendor Registration Form" specified in the Annexure-A.
- 2. Only Correct / relevant information / data have to be furnished at appropriate places along with relevant self attested supporting documents. Any vendor provides false information or grossly inaccurate or forged documents will be disqualified for consideration of registration.
- 3. The applicant should make sure before applying for a particular type of Category, that he meets the prescribed criteria for that type of supply / service.
- 4. Certificates such as "Registration of firms", GST & Income tax clearance, partnership deed, etc. should be in standard format only and it should be issued by the appropriate authority. Dealership certificate should be valid during the period of scrutiny.
- 5. The registration only qualifies a particular vendor for consideration of participating in the case of limited tender for the particular category for which the vendor is registered. 1. **Registration of Firm:** The Bidder shall be a company registered in India under the companies Act. or a partnership firm/proprietor ship firm registered in India.

Scanned copy of the documents, as applicable, in support of registration of the Company/Firm/Proprietorship:

- The registration of the firm, authenticated copy of partnership deed in cases of partnership firm.
- ➤ Attested copy of Memorandom of association and Articles of Association duly registered with Registrar of Company.
- > Duly executed Affidavit, stating that tenderer is the sole proprietor of the firm or any document issued by the taxation authorities establishing that tenderer is the sole proprietor of the firm, in case of proprietorship firm.

with the bid to substantiate eligibility in this regard.

- Valid PAN Number.
- 3. Valid Goods and Services Tax (GST) Registration Certificate No(s).
- 4. Income tax return filed copy for the last 2 financial years
- 5. Experience in terms of Technical Eligibility Criteria:

Experience certificate for successful completion of product/services of category mentioned in registration form.

The experience certificate should be issued by the officer not below the rank of AGM

- 6. Valid EPF/ESI Registration Certificate.
- 7. Near Relationship Certificate, in case of proprietorship firm, the certificate will be given by the proprietor, for partnership firm by all partners and in case of limited company by all the directors of company.

The bidder should give a certificate that none of his/her near relative, as defined below, is working in the BSNL units\*

In case of bidder being proprietorship firm, this certificate will be given by the proprietor. For partnership firm, the certificate will be given by all the partners.

In case of bidder being Company/Limited Company the certificate will be given by all the Directors of the company, **but excluding following:** 

- a) Government of India/Financial institution nominees and independent non-Official part time Directors, appointed by Govt. of India or the Governor of the state and
- b) Full time Directors of PSUs, both Central and State

Due to any breach of these conditions or incorrect declarations by the bidder [Company or firm or any other person], thetender /bid submitted will be cancelled and Bid Security will be forfeited at any stage, whenever it is noticed and BSNL will not pay any damage to the company or firm or the concerned person.

\*Unit, shall be taken as following:

higher), "BSNL unit" is defined as "BSNL as a whole".

- (a) Members of a Hindu undivided family.
- (b) They are husband and wife.
- (c) The one is related to the other in the manner as father, mother, son(s) & Son's wife (daughter in law), Daughter(s) and daughter's husband(son in law), brother(s) and brother's wife, sister(s) and sister's husband (brother in law).
