## **SECTION IV**

#### GENERAL (COMMERCIAL) CONDITIONS OF CONTRACT

**1. APPLICATION:** Submission of bid against this offer shall bind the bidder for the acceptance of all the conditions specified herein or in NIT unless otherwise agreed by BSNL.

#### 2. PERFORMANCE SECURITY DEPOSIT

- a. The successful bidder shall deposit security deposit equivalent to 5% of approved tender cost plus 18% GST (In the form of BG /crossed DD/ FDR (with sign in receipt) placed to AO(A&B) O/o CGMT CG CIRCLE Raipur of BSNL/ Bank Guarantee, valid for 18 months of approved tender cost of work put to tender. If the work is awarded to more than one contractor the security amount as mentioned above will be divided among the number of contractors, on prorata basis.
- b. The Security Deposit shall be released/refunded after completion of Service Provider's performance obligations under the contract Further the release of security deposit will be subjected to recoveries to be made arising out of poor quality of work, incomplete work and/or violation of any terms and conditions of the contract as stipulated in the bid document and on production of "no dues certificate" from "Engineer-in-charge" regarding satisfactory completion of work.
- c. If the Service Provider fails or neglects any of his obligations under the contract it shall be lawful for BSNL to forfeit either whole or any part of performance security furnished by the bidder as compensation for any loss resulting from such failure.
- d. SD will be a non interest bearing deposit, for any period what so ever
- e. SD deposit shall be refunded after the successful completion of the contract period and satisfactory report and NOC for release of SD received from the concerned Unit duly certified by concerned vesicle. The BA may exercise necessary checks and obtain any documents before ensuring the release of SD
- f. The bank guarantee furnished as security deposit should be valid for a period of 18months from the date of agreement. In case the contract period is extended, the BG period shall also be extended accordingly.
- g. In the event of any breach of any terms and conditions of the contract, the contract will be terminated and security deposit will be forfeited to the BSNL.
- h. In the event of failure of the tenderer to supply as stipulated, the amount of Earnest Money and / The security deposit (SD) is required to protect the BSNL against the risk of bidders conduct and will be forfeited in part/ whole in case of -:
  - 1. Unsatisfactory goods / service.
  - 2. Damage caused to BSNL assets and damage/loss to store issued
  - 3. Withdrawal of the successful tenderer from the contract before its expiry without giving proper notice as specified in the terms & conditions of this tender document.
  - 4. Or all or some of the above.

#### 3. EXECUTION TIME LIMIT

3.1The time period as stipulated in the contract or letter of intent shall be deemed to be essence of the contract.

- 4. **PAYMENT TERMS**: The bidder will be required to submit tax invoice in triplicate with work order copy.
  - 4.1.1 95% payment will be released after successful delivery and installation of the items. Rest 5% payment will be released on NOC.
  - 4.1.2 Payment will be released after deduction of all taxes as per laws by AO (A&B) of circle office. For this deduction a TDS certificate will be issued by circle office.
  - 4.1.3 No payment will be made for the goods received in damaged / faulty condition.
  - 4.1.4 Any recovery pointed out by audit will be directly deducted from bills/ Security deposit
  - 4.2 The balance 5% payment shall be released within 6 months from the date of supply of the last consignment of equipment in case there are no damage/shortages. In those cases where such

shortages/damages are intimated to the supplier in writing, the balance payment shall be released only after the cases are settled in accordance with the provision of the P.O.

- 4.3 100% Payment (in place of 95%) may be made on delivery, provided that an additional Bank Guarantee for an amount equivalent to 5% of the value of supplies valid for a minimum period of 7 (seven) months is furnished by the supplier along with an undertaking that the equipment/stores supplied shall be free from damages/shortages. In those cases, where, such shortages/damages are intimated to the supplier in writing, the Bank Guarantee shall be extended without fail by the supplier for a suitable period at the request of the Purchaser in writing. Failure to do so shall result in forfeiture of the Bank Guarantee. The Bank Guarantee will be released only after the cases are settled in accordance with the provisions available in the Bid Documents/purchase Order. In case where the additional Bank Guarantee for 5% is not provided, then the payment will be settled as per clauses 4.1.& 4.2 mentioned above.
- 4.4 GST No 22AABCB5576G2ZU & HSN/SAC should be compulsory mentioned on the invoice. Bill should be submitted by name of "Bharat Sanchar Nigam Limited Chhattisgarh Telecom Circle Raipur (C.G.)"
- 4.5 No interest will be claimed on the delay payment on any ground of dispute or delayed payment.
- 4.6 Any recovery pointed out by audit at any stage and even after the contract period is complete shall be deducted from bills/ Security deposit or any other claim/Tender of the contractor.
- 4.7 BSNL Reserve Right to recover any penalty from the invoices already passed/Paid to the vendor, and even if the bills are already paid and also from other contracts of the contractor as well.
- 5 CLAUSE BY CLAUSE COMPLIANCE. A clause- by clause compliance of service to be provided shall be given as per format attached. In case of deviation a statement of deviation shall be given.
- 6 PRICES
  - i) Rates charged by the contractor for the services given under the contract shall not be higher than the rates quoted by the contractor in his bid.
  - ii) The rates should be quoted with the specific make of the material /equipment including all taxes / charges and it should be valid for a period of minimum one year from the date of acceptance of the tender. In case of reduction of sales tax/ excise duty, it should be assed to the purchaser but no compensation for the increase in the same shall be paid to the supplier.
  - iii) In case of any reduction of taxes and statutory levies (if any) during the contractual period, BSNL shall take the benefit of decrease in such taxes/ duties for the services to be availed from the date of enactment of revised duties/ taxes.
  - iii) In case of increase in taxes/ duties during the contractual period, BSNL shall be liable to revise the rates as per new taxes/ duties for the services to be availed for the remaining period of the contract.

#### 7 TERMNATION OF CONTRACT

- 7.1 BSNL may without prejudice to any other remedy for breach of contract may terminate the contract in whole or in parts.
  - a) If the contractor fails to arrange the supply of any or all items specified in the contract or any extension thereof granted by BSNL.
  - b) If the contractor fails to perform any other obligation (s) under the General Commercial Conditions of the contract.
- 7.2 In case of death of contractor during the period of contract, CGMT CG CIRCLE RAIPUR may at his opinion either immediately terminate the agreement or may require the surviving partner/legal heir of the contractor to complete the contract as per the original agreement.
- **7.3** The CGMT Raipur will not be responsible for any loss damage etc. to the contractor as a result of termination of contract. BSNL will be free to take action to appoint new contractor during the period under notice.

#### 8 TERMINATION FOR INSOLVENCY:

BSNL may also by giving written notice and without compensation to the contractor terminate the contract if the contractor becomes unwilling, bankrupt or otherwise insolvent without affecting its right of action or remedy as hirer.

#### **9 FORCE MAJEURE**

If any time, during the continuance of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reason of any war, or hostility, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts or act of God (Hereinafter referred to as events) provided notice of happenings, of any such eventuality is given by either party to the other within 21 days from the date of occurrence thereof, neither party shall by reason of such events be entitled to terminate this contract nor shall either party have any claim for damages against the other in respect of such on performance or delay in performance under the contract shall be resumed as soon as practicable after such an event may come to an end or cease to exist, and the decision of BSNL as to whether the supplies have been so resumed or not shall be final and conclusive, provided further that if the performance in whole or part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 60 days either party may, at his option terminate the contract.

#### **10 LEGAL JURISDICTION :-**

It is also a condition of this contract that the court, which has territorial jurisdiction upon the place from which the acceptance of tender is issued, shall have absolute jurisdiction for adjudicating any difference or dispute arising of this contract.

#### **11 GST REGISTRATION**

The contractor has to submit the registration of the GST. Otherwise no bill will be initiated for payment till submission of GST registration.

#### **12 RECOVERY OF OVER PAYMENT**

During audit or internal check, if any over payment is noticed, the same can be recovered from the contractor, any of the bills, even if the bills are passed/ paid. BSNL reserve rights to recover the same from other contracts of the vendor also.

#### **13 COURT OF JURISDICTION:**

- 13.1 Any dispute arising out of the tender/bid document/evaluation of bids/issue of WO shall be subjected to the jurisdiction of the competent court of Raipur (C.G).
- 13.2 Where a contractor has not agreed to arbitration, the dispute/claims arising out of the contract/PO entered with him shall be subject to the jurisdiction of the competent court at Raipur (C.G.).
- 14 The bidder should be compliance to Make in India clause according to circular No. P-45021/2/2017-PP(BE-II)-Part(4) Vol.II issued by Ministry of Commerce and Industry Department for Promotion of Industry and Internal Trade (Public Procurement Section) Dated 19.07.2024.
- 15 The signing of agreement shall constitute the award of contract on the bidder. The agreement with the successful bidder shall be signed by the BSNL within a week and submit along with Security Deposit.

### **SECTION V**

### SPECIAL CONDITIONS OF CONTRACT

- 1. The special conditions of contract shall supplement the instruction to the Bidders as contained in section IV and general (commercial) conditions of the contract as contained in section V and wherever there is a conflict, the provisions herein shall prevail over those in section IV and section V.
- 2. In case the date fixed for opening of bids is subsequently declared as holiday by the Government of India, the revised schedule will be notified. However, in absence of such notification, the bids will be opened on next working day, time and venue remaining unaltered.
- 3. BSNL reserves the right to disqualify such bidders who have a record of not meeting contractual obligations against earlier contract entered into with BSNL.
- 4. BSNL reserves the right to blacklist a bidder for a suitable period in case he fails to honor his bid without sufficient ground.

#### 5. NEAR-RELATIONSHIPCERTIFICATE:-

The bidder should give a certificate that none of his/her near relative, as defined below, is working in the BSNL units\*

In case of bidder being proprietorship firm, this certificate will be given by the proprietor. For partnership firm, the certificate will be given by all the partners.

In case of bidder being Company/Limited Company the certificate will be given by all the Directors of the company, **but excluding following:** 

- a) Government of India/Financial institution nominees and independent non-Official part time Directors, appointed by Govt. of India or the Governor of the state and
- b) Full time Directors of PSUs, both Central and State

Due to any breach of these conditions or incorrect declarations by the bidder [Company or firm or any other person], the tender /bid submitted will be cancelled and Bid Security will be forfeited at any stage, whenever it is noticed and BSNL will not pay any damage to the company or firm or the concerned person.

\*Unit, shall be taken as following:

- (a) In case of any near relative of the bidder being non-executive employees, the "BSNL unit "is defined as "Business Area (BA)".
- (b) In case of any near relative of the bidder being executive (up to AGM/STS level), the "BSNL unit" is defined as "BSNL Circle".
- (c) In case of any near relative of the bidder being higher executive (DGM/JAG or higher), "BSNL unit "is defined as "BSNL as a whole".

The near relatives for this purpose are defined as:-

(a) Members of a Hindu undivided family.

(b) They are husband and wife.

(c) The one is related to the other in the manner as father, mother, son(s) & Son's wife (daughter in law), Daughter(s) and daughter's husband(son in law),brother(s) and brother's wife, sister(s) and sister's husband (brother in law).

The format of the certificate is given in Bid document

- 6. The tenderer(s) should give a certificate to the effect that none of his/her such relative is working in the units of BSNL as defined above. In case of proprietorship firm the certificate will be given by the proprietor, for partnership firm certificate will be given by all the partners and in case of Limited company by all Directors of the Company. Any breach of these conditions by the company or firm or any other person, the tender/work will be cancelled and earnest money/security deposit will be forfeited at any stage whenever it is noticed. The BSNL will not pay any damages to the company or firm or concerned person. The company or firm or the person will also be debarred for further participation in the concerned unit.
  - 7. BSNL reserves right to counter offer price against price quoted by the bidder.

- 8. The bidder should be capable to make the supply for every supply order within specified period in the tender.
- 9. Supply period- Supply period of the material against P O is 30 days for all. On delay of supply, he contractor has to pay the penalty as per penalty clause.
- 10. Once the items are not supplied within the originally allotted time excluding the extension. The CGMT Raipur can reduce the amount of the balance supply to any extent without changing other conditions of the contract. The reduced supply can be ordered to the other contractor even on higher rates and the contractor will have to bear the extra expenditure as fixed by CGMT Raipur.
  - a. Delivery Schedule The delivery of the tendered items & services interrelated services shall be completed within 30 days or from the date of issue of purchase order to designated consignees anywhere in C.G. Circle.

- 11. In case of delay or poor quality of supplied material the CGMT Raipur will have the right to cancel the contract and forfeit the security deposit.
- 12. Prices: -The rates should be quoted with the specific make of the material /equipment including all taxes / charges and it should be valid for a period of minimum one year from the date of acceptance of the tender.
- 13. Penalty:- As per General Terms & Conditions of GeM.
- 14. If the contractor refuses to accept the work order for supply of the items, the CGMT Raipur reserves the right to purchase the items from other agencies even on higher rates and the difference of cost will be recovered from the contractor's pending bills or security deposit.
- 15. Parties agree that neither party shall be entitled for any pre-reference or pendent lite interest on its claims,. Parties agree that any claim for such interest made by any party shall be void.
- 16. Evaluation Criteria :- The tender will be evaluated on overall total value wise evaluation
- 17. The bidder should agree to provide an advance sample before the commencement of supply.
