# **SECTION IV**

## GENERAL (COMMERCIAL) CONDITIONS OF CONTRACT

**1. APPLICATION:** Submission of bid against this offer shall bind the bidder for the acceptance of all the conditions specified herein or in NIT unless otherwise agreed by BSNL.

#### SECURITY DEPOSIT

- a. The successful bidder shall deposit security deposit equivalent to 5% of approved tender cost plus 18% GST (In form of BG/crossed DD/FDR (with sign in receipt) placed to AO(A&B) O/o CGMT CG CIRCLE Raipur of BSNL/Bank Guarantee, valid for 18 months of approved tender cost of work put to tender. If the work is awarded to more than one contractor the security amount as mentioned above will be divided among the number of contractors, on prorata basis.
- b. The Security Deposit shall be released/refunded after completion of Service Provider's performance obligations under the contract Further the release of security deposit will be subjected to recoveries to be made arising out of poor quality of work, incomplete work and/or violation of any terms and conditions of the contract as stipulated in the bid document and on production of "no dues certificate" from "Engineer-in-charge" regarding satisfactory completion of work.
- c. If the Service Provider fails or neglects any of his obligations under the contract it shall be lawful for BSNL to forfeit either whole or any part of performance security furnished by the bidder as compensation for any loss resulting from such failure.
- d. SD/EMD will be a non interest bearing deposit, for any period what so ever
- e. SD/EMD deposit shall be refunded after the successful completion of the contract period and satisfactory report and NOC for release of EMD/SD received from the concerned BA duly certified by IFA and BA Head. The BA may exercise necessary checks and obtain any documents before ensuring the release of SD/EMD
- f. SD deposit shall be refunded on verification of all records i.e. EPF, ESI, Labour license, GST payment particular & other liable liabilities.
- g. "No Dues Certificate "produced from "Concerned Department of EPF & ESI etc. After clearance of EPF &ESI and other Govt. liabilities, the performance security shall be released/ refunded to vender.
- h. The bank guarantee furnished as security deposit should be valid for a period of 18 months from the date of agreement. In case the contract period is extended, the BG period shall also be extended accordingly.
- i. In the event of any breach of any terms and conditions of the contract, the contract will be terminated and security deposit will be forfeited to the BSNL.
- j. All the compensation or other sum of money payable by the contractor under the terms of this contract may be deducted from the security deposit or from any sum which may be due or may become due to the contractor by BSNL on any account whatsoever and in the event of his security deposit being reduced by reason of any such deductions, the contractor shall within ten days make good in cash the amount required to make good in full, the security deposit. Otherwise, the said balance in full shall be collected from the running bill of the contractor.
- k. In the event of failure of the tenderer to start the work as stipulated, the amount of Earnest Money and / The security deposit (SD) is required to protect the BSNL against the risk of bidders conduct and will be for
  - 1. Unsatisfactory service.
  - 2. Theft or misappropriation of materials of the BSNL.
  - 3. Damage caused to BSNL assets and damage/loss to store issued
  - 4. Withdrawal of the successful tenderer from the contract before its expiry without giving proper notice as specified in the terms & conditions of this tender document.
  - 5. Or all or some of the above.
- k. bid security shall be forfeited in following cases:
  - (i) If the bidder withdraws his bid during the period of bid validity as mentioned in this document

- (ii) In the case of successful bidder, if the bidder fails:
- a) to sign the contract on allocation of work or
- b) to furnish performance security as required herein

#### 3. EXECUTION TIME LIMIT

3.1 The time period as stipulated in the contract or letter of intent shall be deemed to be essence of the contract.

#### 4. PAYMENT TERMS

- 4.1 The bidder will be required to submit tax invoice within 30 days duly accompanied with complete documents as provided in 4.6 below.
- 4.2 The bills should be sent to BSNL for payment vehicle-wise. It should be ensured that there is no overwriting in the duty slips. In no case, duty slip without signature will be accepted for payment and if it is found so, the amount will be disallowed.
- 4.3 In case the vehicle engaged on monthly basis is to be discontinued during the month, the bill will be paid on performance basis.

  - i) Copy of RC Book for proof of vehicle registered as commercial Permitted Vehicle & having valid Road tax clearance certificate. The vehicles registration should not be older than three years from the month of issue of this NIT.
  - j) Copy of driving license of drivers
  - k) Copy of valid insurance of vehicles.
  - 1) Other Document for fulfilling of Term and condition as prescribed by Motor Vehicle act, 1988
  - m) No payment will be made for vehicles supplied by the Service Provider older than Model specified in bid / NIT .
  - n) Payment proof of GST Challan.
  - o) Labour Identification Number (LIN No) from Shram Suvidha portal under labour Ministry.

#### Note:-

- 1. Contractor shall Maintain all the labour records and submit necessary periodical statements to BSNL. Such records shall be preserved as per the extant guidelines for production before any authority/ tribal etc. as and when required.
- 2. Payment will be released subject to availability of cash/funds. Payment of wages may not be linked with bills payment by the contractor.

- 4.7 No interest will be claimed on the delay payment on any ground of dispute or delayed payment.
- 4.8 Any recovery pointed out by audit at any stage and even after the contract period is complete shall be deducted from bills/ Security deposit or any other claim/Tender of the contractor.
- 4.9 BSNL Reserve Right to recover any penalty from the invoices already passed/Paid to the vendor, and even if the bills are already paid and also from other contracts of the contractor as well.
- **5.** CLAUSE BY CLAUSE COMPLIANCE. A clause- by clause compliance of service to be provided shall be given as per Scope of Work U/S II and General & Commercial Conditions U/S-III. In case of deviation a statement of deviation shall be given.

#### 6. PRICES

- i) Rates charged by the contractor for the services given under the contract shall not be higher than the rates quoted by the contractor in his bid.
- ii) In case of any reduction of taxes and statutory levies (if any) during the contractual period, BSNL shall take the benefit of decrease in such taxes/ duties for the services to be availed from the date of enactment of revised duties/ taxes.
- iii) In case of increase in taxes/ duties during the contractual period, BSNL shall be liable to revise the rates as per new taxes/ duties for the services to be availed for the remaining period of the contract.
- iv) If any vehicle is sent to places anywhere in CG or outside CG the responsibility to pay toll tax en route will be responsibility of the bidder/contractor. The same can be claimed with invoices.
- v) The rate should be on monthly basis as well as daily basis. The KM slabs for monthly hire and Time-KM slabs for daily hire are shown in SCOPE OF WORK in SECTION-VII

#### 7. PRICE REVISION:

7.1 No escalation is admissible on any account whatsoever during the first three months of the contract. After three months of contract increase or decrease in hire charges due to variation in Fuel rates will be worked out and paid only when the variation to base rate is above 10%. Such increase or decrease in the hire charges due to these variations shall be worked out from the base rate on the following formula:

#### **Increase or decrease in Petrol/Diesel during the month =**

Actual KMs run by the vehicle X (Revised rate per liter - Base rate per liter) Average KM per liter of Diesel / Petrol consumption (KMPL)

(Note:- The Base Rate of Petrol/Diesel is the prevailing rate on the date of commencement of work / contract. The Average KMPL is to be assumed as 9Kms in case of AC cars and 12 Kms in case of Non-AC Cars in both Petrol & Diesel driven. If there is decrease in Fuel Price, formula will indicate negative figure which means the deduction shall be done from the bill).

- 7.2 The review for change in hire charges due to change in fuel rates shall be affected at the end of quarter, irrespective of start of contract i.e. on 31st March, 30th June, 30 Sept, and 31st December. The change in hire charges, if any, shall be applicable from the I<sup>st</sup> day of next quarter. Base Rate of fuel would be fuel prices as on date of award of contract.
- 7.3 In case of minimum average run per liter of fuel (i.e. Average KMPL) as assumed above is not achieved by any vehicle, then the extra cost of fuel consumed by the vehicle on the basis of actual KMPL of fuel will be deducted from the payment due for that vehicle.
- 7.4 The service provider shall submit supplementary bill for reimbursement towards increase in Fuel price on monthly basis without accumulation. This supplementary bill is to be supported with proof of fuel price prevailing on 1<sup>st</sup> of the month.

#### 8. TERMINATION OF CONTRACT

- 8.1 BSNL may without prejudice to any other remedy for breach of contract may terminate the contract in whole or in parts.
  - a) If the contractor fails to arrange the supply of any or all of the vehicles within the period (s) specified in the contract or any extension thereof granted by BSNL.

- b) If the contractor fails to perform any other obligation (s) under the General & Special Conditions of the contract.
- 8.2 BSNL may without prejudice, to other rights under law or the contract provided get the hiring of vehicles done at the risk and cost of the contractor, in above circumstances.
- 8.3 All instructions, notices and communications etc. under the contract given in writing and if sent to the last known place of business, shall be deemed to be served on the date, even in ordinary course of post, these would have been delivered to the Service Provider.
- 8.4 Notwithstanding anything contained herein, BSNL also reserves the right to terminate the contract at any time or stage during the period of contract, by giving two days notice in writing without assigning any reason and without incurring any financial liability whatsoever to the Service Provider.
- 8.5 In case of death of contractor during the period of contract, CGMT CG CIRCLE RAIPUR may at his opinion either immediately terminate the agreement or may require the surviving partner/legal heir of the contractor to complete the contract as per the original agreement.
- 8.6 If it came to the notice of buyer regarding any default in payment of EPF/ESI from any source during the contract period then the contract will be terminated.

#### 9. TERMINATION FOR INSOLVENCY:

BSNL may also by giving written notice and without compensation to the contractor terminate the contract if the contractor becomes unwilling, bankrupt or otherwise insolvent without affecting its right of action or remedy as hirer.

#### 10. FORCE MAJEURE

If any time, during the continuance of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reason of any war, or hostility, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts or act of God (Hereinafter referred to as events) provided notice of happenings, of any such eventuality is given by either party to the other within 21 days from the date of occurrence thereof, neither party shall by reason of such events be entitled to terminate this contract nor shall either party have any claim for damages against the other in respect of such on performance or delay in performance under the contract shall be resumed as soon as practicable after such an event may come to an end or cease to exist, and the decision of BSNL as to whether the supplies have been so resumed or not shall be final and conclusive, provided further that if the performance in whole or part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 60 days either party may, at his option terminate the contract.

#### 11. ARBITRATION

11.1 In the event of any question, dispute or difference arising under the agreement or in connection there with (except as to the matters, the decision to which is specifically provided under this agreement), the same shall be referred to sole arbitration of Chief General Manager Telecom, CG Telecom Circle Raipur of Bharat Sanchar Nigam limited (BSNL) of the respective Circles/District or any other person appointed by him. In case his designation is changed or his office is abolished then in such case to the sole arbitration of the officer for the time being entrusted whether in addition to the function of the Chief General Manager Telecom, CG Telecom Circle Raipur or by whatever designation such officers may be called (hereinafter referred to as the said officer). In the event of such Arbitrator to whom the matter is originally referred to vacates his office on resignation or otherwise or refuses to do work or neglecting his work or being unable to act as Arbitrator for any reasons whatsoever, the Chief General Manager Telecom, CG Telecom Circle Raipur of BSNL shall appoint another person to act as Arbitrator in the place of outgoing Arbitrator and the person so appointed shall be entitled to proceed further with the reference from the stage at which it was left by the predecessor and that the award of the arbitrator shall be final and binding on both the parties. Contractor will have no objection in any such appointment that arbitrator so appointed is an employee of BSNL or a Government Servant or that he has to deal with the matter to which the agreement relates or that in the course of his duties as a BSNL employee he has expressed his views on all or any of the matters in dispute. The adjudication of such Arbitrator shall be governed by the provisions of the Arbitrator and Conciliation Act 1996, or any statutory modification or re-enactment there of or any rules made thereof.

- 11.2 The venue of Arbitration proceeding shall be Office of Chief General Manager Telecom, CG Telecom Circle, Raipur of BSNL or such other place as the arbitrator may decide.
- 11.3 The arbitrator may from time to time with the consent of both the parties enlarge the time frame for making and publishing the award. Subject to aforesaid arbitration and conciliation Act, 1996 and the rules made there under, any modification thereof for the time being in force shall be deemed to apply to the arbitration proceeding under this clause.
- 11.4 As Per corporate office letter no. MMS/135-1/2011-12(Pt.)/70 Dated 28/12/2017 Revision of Arbitration Guideline in BSNL in accordance with arbitration and conciliation (Amendment) Act, 2015 (3 of 2016) Modification required in tender clause regarding fast track procedure shall be applicable where the claim amount is up to **Rs. 5 crores**.

#### 12. SET OFF

Any sum of money due and payable to the contractor (including security deposit refundable to him) under this contract may be appropriated by BSNL and set off the same against any claim of BSNL for payment of a sum of money arising out of this contract or under any other contract made by contractor with BSNL.

#### 13. INSPECTION:-

BSNL shall have the right to cause an examination of the work and the final bills of the contractor including all supporting vouchers, abstract etc. to be made after payment of the final bill and if as a result of such audit and technical examination any sum is found to have been over paid in respect of any work done by the contractor under the contract or any work claimed by him to have been done by him under the contract and found not to have been executed, the contractor shall be liable to refund the amount of over payment and it shall be lawful for BSNL to recover the same from him through the PBG or future bills.

#### 14. LEGAL JURISDICTION:-

It is also a condition of this contract that the court, which has territorial jurisdiction upon the place from which the acceptance of tender is issued, shall have absolute jurisdiction for adjudicating any difference or dispute arising of this contract.

#### 15. REASONABLENESS OF RATES

The rates quoted by the contractor must be unambiguous, reasonable and logical. The tender can be rejected on the basis of unreasonable and illogical rates.

#### 16. COUNTER OFFER

The CGMT CG CIRCLE reserves the right to counter offer prices against prices quoted by any Tenderer.

#### 17. WORKMANSHIP

In case of poor workmanship or if the work/supply is not done in time and in view of exigency of the work/supply, if it is considered necessary to carry out the work/supply by some other means or to assign the work/supply to some other parties due to the failure on the part of the contractor, 15 day's time will be given to the contractor to correct or complete the work/supply failing which the work/supply can be got done by other means at the risk and cost of the contractor.

#### 18. <u>AUDIT AND TECHNICAL EXAMINATION:</u>

18.1 BSNL shall have the right to cause an audit and technical examination of the work and the final/last/any bills of the contractor including all supporting vouchers, abstract etc. to be made after payment of the final bill and if as a result of such audit and technical examination any sum is found to have overpaid in respect of any work done by contractor under the contract or any work claimed by him to have been done by him under the contract and found not to have been executed, the contractor shall be liable the refund the amount of over payment and it shall be lawful for BSNL to recover the same from him in the manner prescribed in clause with the heading payment of bills (same chapter), or in any other manner legally permissible and if it is found that the contractor was paid less than what was due to him under the contract in respect of any work executed by him under it, the amount of such under payment shall be duly paid by BSNL to the contractor.

- 18.2 Provided that BSNL shall be entitled to recover any sum overpaid, nor the contractor shall be entitled to payment of any sum paid short where such payment have been agreed upon between the Divisional Engineer or his subordinate officer on one hand and the contractor on the other under any term of the contract permitting payment for work after assessment by the **CGMT CG CIRCLE Raipur** or his subordinate officer.
- 18.3 Any sum of money due and payable to the contractor including security deposit returnable to him under this contract may be appropriate by the BSNL for the payment of a sum of money arising out or under any other contract made by the contractor with the BSNL

#### 19. GST REGISTRATION

The contractor has to submit the registration of the GST. Otherwise no bill will be initiated for payment till submission of GST registration

#### 20 RECOVERY OF OVER PAYMENT

During audit or internal check, if any over payment is noticed, the same can be recovered from the contractor, any of the bills, even if the bills are passed/ paid. BSNL reserve rights to recover the same from other contracts of the vendor also.

#### 21. Deleted

#### 22. COURT OF JURISDICTION:

- 22.1 Any dispute arising out of the tender/bid document/evaluation of bids/issue of WO shall be subjected to the jurisdiction of the competent court of Raipur (C.G).
- 22.2 Where a contractor has not agreed to arbitration, the dispute/claims arising out of the contract/PO entered with him shall be subject to the jurisdiction of the competent court at Raipur (C.G.).

#### 23 PAYMENT INSULATION UNDER TAKING:-

The Bidder is required to submit a payment insulation under taking that he has sufficient capital resources at his disposal so that he will make due payments to the laboures/ workers /Working of this tender / contract every month as per laws without linking it with payments from BSNL and carry out operations of tender without linking it with payments from BSNL.

### 24 TERMINATION FOR DEFAULT

- 24.1. BSNL may, without prejudice to any other remedy for breach of contract, by written notice of default sent to the vendor, terminate this Contract in whole or in part.
  - a) If the Vendor fails to provide the vehicle & drivers within the time period (s) specified in the Contract, or any extension thereof granted by BSNL.
  - b) If vendor fails to perform any other obligation(s) of the Contract; and
  - c) If Vendor, in either of the above circumstance(s), does not remedy his failure within a <u>period of 15 days</u> (or such period as the Purchaser may permit in writing) after receipt of the default notice from BSNL.
- 24.2. In the event the BSNL terminates the contract in whole or in part, pursuant to para 24.1above,BSNL may ask the Vendor to continue performance of the contract to the extent till contract is not terminated.

#### 25 SPECIAL RIGHTS OF CGMT CG CIRCLE

- 1. In case of any dispute between the two contracting parties, the decision of the CGMT CG CIRCLE RAIPUR will be final.
- 2. The CGMT CG CIRCLE RAIPUR is not bound to accept the lowest tender, and also reserves the right to reject any or all the tenders so received without assigning any reason.
- 3. The CGMT CG CIRCLE RAIPUR reserves the right to disqualify such bidders who have a record of not meeting the contractual obligations against earlier contracts entered with the department.
- 4. The CGMT CG CIRCLE RAIPUR reserves the right to increase or decrease the duration and validity of the contract from normal one year duration in the interest of the department.
- 5. In case of any dispute, case would be referred to the CGMT CG CIRCLE, RAIPUR or any other authority looking after the duties/works of CGMT CG CIRCLE, RAIPUR and he would be the sole arbitrator. His decision would be final and binding on all cases.

- 6. The CGMT CG CIRCLE, RAIPUR reserves the right to award the works to more than one bidder as per BSNL Procurement guidelines, if required in the interest of the department
- 7. Tenders with any condition including that of conditional/unconditional rebates shall be rejected forthwith.
- 8. All provisions of statutory acts enacted by the Govt. or other Local formalities issued by other statutory bodies and local authorities from time to time shall be fulfilled /complied at the cost of bidder/tenderer.
- 9. The CGMT CG CIRCLE RAIPUR reserves the right to black list the contractor and forfeiture of EMD if contractor submits false /Bogus certificates/ documents and found in any illegal activity or any such activity which is, in contravention to the general policy, statutory provision, rules, regulation as announced or declared or published by any competent authority.

#### 26 GENERAL TERMS AND CONDITIONS:

- 1. The company reserves the right to withhold or delay the payment of the contractor in case of any pending disputes.
- 2. In the event of any question, dispute or difference arising under this agreement or in connection there-with (except as to the matters, the decision to which is specifically provided under this agreement), the same shall be referred to the sole arbitrator appointed by BSNL.
- 3. BSNL's decision will be final on all matters relating to the business and will be binding on the contractor.
- 4. It will be BSNL's Endeavour to make the payment to the contractors as per the schedule, however this may stretch beyond the scheduled time only in case of delays in getting claims from the contractors or in case of incorrect claims
- 5. All contractors' representatives will report to BA Head/ competent Authority through the nodal officer appointed by BA Head/Competent Authority.
- 6. All present, future & additional taxes /Levies/ duties etc. that may be levied by the govt./ Local authorities etc. will be borne by the contractors.
- 7. The contractor's representatives shall comply with all applicable laws, bye Laws, rules, regulations, orders, directions, and notifications etc of the Govt. / Court/Tribunals and shall also comply with all directions issued by BSNL and provide BSNL with all information and cooperation that BSNL may reasonably require from time to time.
- 8. The contractor's representatives have to fully cooperate with BSNL to investigate any complaint from the public/staff.
- 9. The contractor shall ensure provision of necessary safety devices tools/ kits etc required for discharge of services as mentioned in Section VII at his own cost and shall recoup the same from time to time.
- 10. Contractor shall be liable for all payments of minimum wages, Salary etc to its employees & shall comply with all statutory laws, rules, relating to employment, wages, EPF, ESI, ID, act etc.
- 11. The Contractor shall be liable for any theft; sabotage etc. of BSNL property and the Damages / losses if any will be recovered from the contractor. The contractor shall report any such incident to the site in charge immediately.
- 12. The Contractor agrees to protect, defend, indemnify and hold harmless BSNL and its employees, officers, directors, agents or representatives from and against any and all liabilities, damages, fines, penalties and costs (including legal costs and disbursements) arising from or relating to:
- a) Any breach of any statute, regulation, direction, orders or standards from any governmental body, agency, telecommunications operator or regulator applicable to such party; or
  - b) Any breach of the terms and conditions in this agreement by Contractor This clause shall survive even on the termination or expiry of this agreement.
- 13. BSNL Shall not be liable for any act of commission or omission of any third party.
- 14. The Contractor's representatives will have to abide by the policy rules, regulations & instructions of BSNL as revised/modified from time to time, without any prior notice to the Contractor in respect of all matters including security deposit / PBG, payment to the contractor etc.
- 15. The Contractor will be bound by all the aspects and legal issues relating to the labour laws.
- 16 Risk Clause: BSNL Raipur reserves the right to discontinue the service at any time, if the services are found unsatisfactory by giving a show cause to be replied within a week and also has the right to award the contract

- to any other agency at the risk and cost of current agency and excess expenditure incurred on account of this can be recovered from Security deposit or pending bills or by raising a separate claim.
- 17 The BSNL will not be responsible either to the Contractor or to its workers deployed at these work points for any medical assistance/injuries/death or any kind of loss occurred to employees deployed by the contractor
- 18 The contractor shall be fully responsible for the damages caused by the workmen supplied under his tender during execution of work, to the properties belonging not only to BSNL but also to other Departments, Organizations, Other Private Operators/ Organizations and individuals and the cost of such damages will be recovered from the amount payable to the contractor.
- 19 The persons employed by the bidder are to be paid by the bidder with fair wages as per Labour Laws of Central/State Government. Other benefits to the persons like Bonus, ESI, Gratuity, PF etc., are complete responsibility of the bidder. Any injury/mishap caused to the worker during the course of work shall be the responsibility of the bidder.
- 20 The bidder is governed by the Workman's Comp persons employed by him/her/firm. The Service Contractor shall indemnify the Department of all claims made by the employees of the service contractor.
- 21 Bidder shall have insurance / Group insurance scheme for the employees deployed for CONTRACT.
- 22 The bidder shall provide proper identity card to the persons utilized.
- 23 The bidder should be compliance to Make in India clause according to circular No. P-45021/2/2017-PP(BE-II)-Part(4) Vol.II issued by Ministry of Commerce and Industry Department for Promotion of Industry and Internal Trade (Public Procurement Section) Dated 19.07.2024.

## **SECTION V**

## **SPECIAL CONDITIONS OF CONTRACT**

- 1. The special conditions of contract shall supplement the instruction to the Bidders as contained in section IV and general (commercial) conditions of the contract as contained in section V and wherever there is a conflict, the provisions herein shall prevail over those in section IV and section V.
- 2. In case the date fixed for opening of bids is subsequently declared as holiday by the Government of India, the revised schedule will be notified. However, in absence of such notification, the bids will be opened on next working day, time and venue remaining unaltered.
- 3. BSNL reserves the right to disqualify such bidders who have a record of not meeting contractual obligations against earlier contract entered into with BSNL.
- 4. BSNL reserves the right to blacklist a bidder for a suitable period in case he fails to honor his bid without sufficient ground.
- 5. The liability under relevant sections of Motor Vehicle Act 1968 and IPC causing death or permanent liability developed in the vehicle supplied by the contractor, the hiring authority has no responsibility of whatsoever and will not entertain any claim in this regard under the provision of the law.
- 6. The engagement and employment of drivers and payment of wages to them as per existing provisions of various labour laws and regulations is the sole responsibility of the contractor and any breach of such laws or regulations shall be deemed to be breach of this contract.

#### 7. NEAR-RELATIONSHIP CERTIFICATE: -

The bidder should give a certificate that none of his/her near relative,as defined below, is working in the BSNL units\*

In case of bidder being proprietorship firm, this certificate will be given by the proprietor. For partnership firm, the certificate will be given by all the partners.

In case of bidder being Company/Limited Company the certificate will be given by all the Directors of the company, **but excluding following:** 

- a) Government of India/Financial institution nominees and independent non-Official part time Directors, appointed by Govt. of India or the Governor of the state and
- b) Full time Directors of PSUs, both Central and State

Due to any breach of these conditions or incorrect declarations by the bidder [Company or firm or any other person], thetender /bid submitted will be cancelled and Bid Security will be forfeited at any stage, whenever it is noticed and BSNL will not pay any damage to the company or firm or the concerned person.

\*Unit, shall be taken as following:

- (a) In case of any near relative of the bidder being non-executive employees, the "BSNL unit" is defined as "Business Area (BA)".
- (b) In case of any near relative of the bidder being executive (up to AGM/STS level), the "BSNL unit" is defined as "BSNL Circle".
- (c) In case of any near relative of the bidder being higher executive (DGM/JAG or higher), "BSNL unit" is defined as "BSNL as a whole".

The near relatives for this purpose are defined as:-

- (a) Members of a Hindu undivided family.
- (b) They are husband and wife.
- (c) The one is related to the other in the manner as father, mother, son(s) & Son's wife (daughter in law), Daughter(s) and daughter's husband(son in law), brother(s) and brother's wife, sister(s)and sister's husband (brother in law).

The format of the certificate is given in Appendix-III(A.

- 8. The tenderer(s) should give a certificate to the effect that none of his/her such relative is working in the units of BSNL as defined above. In case of proprietorship firm the certificate will be given by the proprietor, for partnership firm certificate will be given by all the partners and in case of Limited company by all Directors of the Company. Any breach of these conditions by the company or firm or any other person, the tender/work will be cancelled and earnest money/security deposit will be forfeited at any stage whenever it is noticed. The BSNL will not pay any damages to the company or firm or concerned person. The company or firm or the person will also be debarred for further participation in the concerned unit.
- 9. The contractor shall assign the job of driving of hired vehicles only to qualified experienced licensed drivers and also assume full responsibility for the safety and security of the officers/officials as well as essential store items while running the vehicle by ensuring safe driving. The attested copy of driving license of all such drivers should be submitted during the contractual period. The BSNL shall have no direct or indirect liability arising out of such negligent, rash and impetuous driving which is an offence under section 29 of IPC and any loss caused to BSNL have to be suitably compensated by contractor.
- 10. The contractor shall when called upon to do so, place at the disposal of BSNL such number of vehicles as may be required although the number of vehicles so demanded may be more than the number of vehicles he is required to supply for the purpose of execution of the contract at same rate and terms and conditions. The number of such vehicles to be supplied extra will not be more than 25% of original schedule or requirement in the NIT.
- 11. In no case a vehicle that is not registered for the commercial purpose shall be supplied to BSNL and taxes, insurances, Road tax etc. due on such vehicles shall be liability of the contractor. The attested copy of R/C Book and the Insurance policy of vehicles supplied under this contract should be submitted to the authorized person of the BSNL and will be subject to scrutiny.
- 12. The contractor shall send the vehicle for periodical servicing at the cost of the contractor, BSNL will not pay any mileage run for such servicing nor any deduction be made for the duration involved in such servicing. The cost of lubricants, repairs, maintenance, taxes insurance, etc. will be to the contractor's liability.
- 13. BSNL reserves right to counter offer price against price quoted by the bidder.
- 14. No liability whatsoever for payment of wages/salaries other benefits and allowances to his personnel that might become applicable under any Act or Order of the Govt. in this regard and the Service Provider shall indemnify BSNL against any/all claims which may arise under the provisions of various Acts, Government Orders etc. and any breach of such laws or regulations shall be deemed to be breach of this contract.

#### 15 DISTRIBUTION OF WORK

- 15.1. The CGMT CG CIRCLE Raipur shall have the sole discretion in determining the number of Contractors on whom the work orders shall finally be placed. If multiple bids are accepted, the terms and conditions offered to the lowest shall also apply to the higher bids.
- 15.2 General policy of distribution: The CGMT CG CIRCLE RAIPUR reserves the right to award the works to more than one bidder as per CVC guidelines, if required in the interest of the department.
- 15.3 CGMT CG CIRCLE Raipur also reserves the right for the placement of order of the balance quantity or part of L1 quantity, to L2 bidder at L1 rate in case of degraded performance of L1 bidder during any stage of the contract.
- 15.4 BSNL reserves the right to depart from the above guidelines for distribution of order quantities amongst successful bidders depending upon the urgency and other factors prevailing at the time of evaluating the bids.
- 15.5. Regular checking of meter by the designated transport authority may be done by the contractor, and requisite certificate may be shown to BSNL as and when demanded.
- 16. The contractor should ensure that at the end of duty; the duty slips are completed and signed by the users. The log book in duplicate copy form to be printed and serially numbered by the contractor as per the format given in Section-X.

- 17. The contractor shall provide his employees a uniform, which shall be worn by them all the time while on duty.
- 18. LCV means Light Commercial Vehicle as defined in Motor Vehicle act 1988. The BSNL reserves the right to inspect & approve the vehicle along with its type before hiring as per requirement. Normally BSNL will take Hard Top LCV's like Bolero, TUV-300, Sumo etc.

#### 19. COMPLIANCE WITH LAWS AND REGULATIONS

During the performance of the supply the Contractor shall at his own cost and initiative fully comply with all applicable Laws of the Land and with any and all applicable By-laws, Rules, Regulations and Orders and any other Provisions having the force of Law made or promulgated or deemed to be made or promulgated by any Government, Governmental agency or Department, Municipal Board, Government or other regulatory or Authorized Body of persons and shall provide all certificates of compliance therewith as may be required by such applicable Law, By-laws, Rules, Regulations, Orders and/or Provisions. The Contractor shall assume full responsibility for the payment of all contributions and payroll taxes, as to his employees, servants or agents engaged in the performance of the work specified in the Contract Documents. If the Contractor shall require any assignee or sub-contractor to whom any portion of the work to be performed hereunder may be assigned, sub leased or sub-Contractor to comply with the provisions of the Clause and in this connection the Contractor agrees as to undertake to save and hold the Department harmless and indemnified from and against any/all penalties, actions, suits, losses and damages, claims and demands and costs (inclusive between attorney and client) charges and expenses whatsoever arising out of occasion, indirectly or directly, by failure of the Contractor or any assignee or sub-contractor to make full and proper compliance with the said By-laws, Rules, Regulations, Laws and Order and Provisions as aforesaid.

- 20. The Contractor shall comply with all provisions of the "Payment of wages Act 1936, Minimum Wages Act 1948, Employees Liability Act 1938, Workmen's Compensation Act 1923, Industrial Disputes Act 1947, Maternity Benefits Act 1961, and the Contractor Labour (Regulation and Abolition) Act 1970 & Motor Vehicle act 1988 or the modifications thereof or any other laws relating thereto and the rules made there under from time to time. The Contractor shall indemnify Department against payments to be made under for the observance of the Laws aforesaid notwithstanding his right to claim indemnity from his sub-Contractors. The regulations aforesaid shall be deemed to be a part of this contract and any breach thereof shall be deemed to be a breach of this contract.
- 21. In every case in which by virtue of the provisions of Section 12, sub-section (i) of the Workmen's Compensation Act, 1923, Department is obliged to pay compensation to a workman employed by the Contractor, in execution of the supply, Department will recover from the Contractor the amount of the compensation so paid, and without prejudice to the rights of the Government under Section 12, sub-section (ii) of the said Act, Department shall be at liberty to recover such amount or any part thereof by deducting it from the security deposit or from any sum due by Department to the Contractor whether under this contract or otherwise. Department shall not be bound to contest any claim made against it under Section- 12, sub-section (i) of the said Act, except on the written request of the Contractor and upon his giving to Department full security for all costs for which Department might become liable in consequence of contesting such claim.
- 22. (A) Subject to provisions of Contract Labour (Regulation and Abolition) Act 1970 and Contract Labours Rules 1971 as amended time to time, Contractor shall register themselves after receipt of letter of acceptance of the tender with concerned licensing authority as per Contract Labour (Regulation and Abolition) Act 1970 and Contract Labour Rules 1971& Motor Vehicle act 1988 as amended from time to time as applicable, and shall commence the actual work only after receipt of license from concerned licensing authority under the provision of the Contract Labour (Regulation and Abolition) Act 1970 and Contract Labour Rules 1971 as amended from time to time and continue to have valid license until completion of work.
  - (B) The bidder is required to submit a payment insulation under taking that he has sufficient capital resources at his disposal so that he will make due payments to the labours / workers / working of this tender/ contract every month as per laws insulating with payments from BSNL and carry out operations of tender without linking it with payments from BSNL. (It may be noted that BSNL makes payments twice a month based on status of submitted & passed invoices available with paying authority as per current policy)

#### 23. COMPLIANCE OF PROVISIONS OF EPF ACT 1952

The contractor will ensure compliance of Employees Provident Fund & Misc. Provisions Act 1952 & Employees Provident Fund Scheme 1952 in respect of laborers/ employees engaged by him for performing the supply of BSNL.

#### 24. COMPLIANCE OF PROVISIONS OF ESI SCHEME

The contractor will ensure compliance of ESI Scheme & Misc. Provisions Act in respect of laborers/ employees engaged by him for performing the supply of BSNL as applicable.

#### 25. EVALUATION CRITERIA:-

- 1) The tender will be evaluated on overall lowest cost of hiring of all types of vehicles for tenders participated in a business area.
- 2) For out station journey and halt, over time payment claim will not be applicable.
- 3) In price schedule table, rates for No. of Kms have to be filled in the financial bid as per format given in the bid
- 4) Deleted
- 5) Bid that is most beneficial/ economical to BSNL will be the one, evaluated as most attractive and will be finally accepted.

#### Note:-

- 1. The BSNL will not be responsible either to the Contractor or to its workers deployed at these work points for any medical assistance/injuries/death or any kind of loss occurred to employees deployed by the contractor.
- 2. All online documents should be submitted Original (Scanned) or self-attested in case of Xerox copy, Bid will be rejected if online documents are not submitted as mentioned above.
- 3. Bidders who have been rescinded /debarred by Tendering authority/Higher BSNL Unit as the case may be including for reasons for failing to sign necessary agreement with the concerned Tendering authority in stipulated time on earlier occasions, will not be eligible to participate in the tender for the same work.
- 4. For participating in e-Tendering process bidder shall access e-Bid document uploaded on the e tender portal and pay requisite tender processing fee as defined for the tender by e-tender service provider.
- 5. The evaluation of the Tender will be done for quoted price including GST.

## **SECTION-VI**

## SCOPE OF WORK (Schedule of Requirement)

The Bidder is required to provide commercial vehicles fully conforming to RTA/RTO regulation along with fuel, driver etc and carryout periodical maintenance and execute the work through their Supervisor.

NOTE: The Tables shown above are only indicative and for regular work. The actual deployment may vary from time to time depending on work schedule, company's policy, intensity of maintenance and interruption duties and developmental activities etc. The additional requirement for a short period to meet the 'Peak Operational requirement' if any on day to day basis is also to be met with at the same rate quoted for regular work. The number of such requirement is not anticipated in this tender but may not exceed 25% of the above estimated quantity.

## **SECTION VII**

#### SERVICES TO BE PROVIDED

- 1. **SERVICE**: Provision of vehicles with licensed drivers, registered commercial vehicles on hiring basis for running in the Business Area / Chhattisgarh Telecom Circle & anywhere in the jurisdiction of BSNL when required.
- 2. PERIOD OF CONTRACT: Under normal circumstances the contract shall be valid for a period of One year from date of Agreement. However contract may be extended for further period upto one year, on the same rate, terms and conditions after ensuring competitiveness of the rates.
- 3. **QUANTITY**: Estimated number of vehicles to be hired is as per NIT however it should be clearly noted that BSNL shall place the order only as per the actual requirement from time to time.
- 4. **DUTY HRS**.As per requirement, the vehicle can be called any time, any day for any number of hours . (Duty Hours of vehicles are normally for ten hours per day) either at a stretch or in parts.
- 5. **NOTICE PERIOD** for supply of vehicles shall be one day in advance for Regular requirements. Three hour in advance for additional requirement during office hours. Telephonic intimation shall be considered as notice.
- 6. **REPORTING PLACE**: Normally any place within the jurisdiction of General Manager BUSINESS AREA (Name)......... & anywhere in BSNL in case of specific requirement approved by CGMT CG CIRCLE Raipur.
- 7. **COUNTING OF DISTANCE**: will be from the starting point of the user and closing at the point wherever user completes his/her travel. The distance covered in each way between user delivery address and the garage/ normal parking place will be allowed on actual basis or 5KMs whichever is less.
- 8. **ACCURACY OF METER**: The meter reading should tally the actual distance of run at any instant and authorized officer shall have full power to check up the meter for its correctness and to take action accordingly.

#### 9. PENALTIES

- (1) In case of break down, after it's reporting for duty, the vehicles will have to be replaced by same type immediately or delay should not be more than one hour. In case of non-availability of suitable vehicle a penalty up to Rs. 2000/- shall be imposed in addition to deduction on pro-rata basis for the period.
- (2) The penalty for absence during extra Hour duty will be Rs. 200 per occasion and for Temporary absence during duty hours without valid permission shall be Rs. 150/- per hour of absence.
- (3) In case of non-availability of vehicles for any particular day penalty of Rs. 1,000/- per day shall be imposed in addition to deduction of hire charges on pro-rata basis for the period.
- (4) If the vehicle provided by the Service Provider is found to be not in good condition or without proper document; the vehicle may be rejected and sent back. No payment shall be made on account of such rejection. However in case of dispute the decision of CGMT BSNL CG Raipur would be final.
- (5) No payment will be made for vehicles supplied by the Service Provider older than Model specified in bid / NIT.
- 6) Should not refuse to provide vehicles against BSNL's requirement and on each refusal a penalty as given at item (3) above will be deducted from the running bills besides any other action which may even lead to termination of contract.

#### 10. SPECIAL REQUIREMENT:-

- i) Telephones-Intending bidder must have a telephone where requisition of vehicles can be conveyed all the 24 hrs. Telephone No. must be specified in the bid.
- ii) Identity Cards- Intending bidder should arrange issue of proper Identity Cards after verifying the antecedents of his drivers through' Local Govt. offices.
- iii) Drivers: attested copy of driving license should be submitted during the contractual period. Drives must be trained to formalities manners & etiquettes of corporate drivers to be observed during operation of vehicle
- iv) Govt. Tax / Levy / Duty: Payment of any Govt. tax or duty for supplying the vehicles in Jurisdiction of CGMT CG Raipur will be liability of contractor.
- v) Parking and Toll charges, if any, may be claimed by producing valid parking / Toll slips.

- vi) Shortage in utilization of contracted Kms if any during a Particular month will be suitably adjusted over a residual period of contract. Consumables like lubricants, tyres, battery and repairs and maintenance, taxes, insurance etc. will be to the service provider liability.
- vii) Documents of vehicles-The attested copy of R/C Book Permit and the Insurance policy of vehicles supplied under this contract should be submitted to the authorized person of the BSNL and will be subject to scrutiny.
- viii) Mandatory Requirements: Drivers must be equipped with (i)BSNL Mobile phone, (ii) Identity card, (iii) Uniform, (iv) Driving license (Professional),(v)clearance certificate from traffic police. Not adhering to above requirements will be treated as non-performance. Attested copy of driving license (professional) must be submitted during the contractual period. Drivers must have an experience of three years. Experience will be verified at the time of engaging driver. Proper Identity Cards after verifying the antecedents of his drivers' through Local Govt. offices.
- ix) Assign driving to only qualified experienced licensed drivers and also assume full responsibility for the safety and security of the officers/officials and store items.
- x) Duty Slips in duplicate copy to be printed and serially numbered by the Service Provider as per prescribed format of BSNL (Section XI) and should ensure that at the end of duty; the duty slips are completed and signed by the users.
- xi) Vehicles Up-keep shall be in good condition along with good and clean Seat covers & curtains. Vehicles so hired may be inspected by a pre-designated committee of BSNL officers with reference to good/properly maintained vehicle including cabin, upholstery, seats etc.
- xii) Unused KMs ,if any, during a particular month (monthly KM slabs) will be carried over to the subsequent three months and will be adjusted against any extra KMs if performed over and above the agreed slab for the hired vehicle. A certificate to this effect is given on the body of bill while submitting claim for payment. If the shortage mileage is not adjusted within a period of 3 months bill, a proportionate amount (on basic KM basis) will be deducted at the end of the 4th month bill.

#### 11. DEBARRING CONDITIONS:-

- (i) No vehicle should be supplied having registration in the Name of employee of BSNL or their close relative and a Certificate to this effect be given on the body of bill while submitting claim.
- (ii) No sub-contracting of the Service allotted is permissible by BSNL.
- (iii) The near relatives of all BSNL employees either directly recruited or on deputation are prohibited from participation in this tender. The tampering of meter reading, vehicle usage timings, overwriting of Summary / log sheet and misbehavior of driver while on duty shall be viewed seriously, leading to even cancellation of contract.
- (iv) Service Provider shall not engage any person below 18 years of age.

### 12. BSNL WILL NOT HAVE OBLIGATION:-

- (i) No liability whatsoever for payment of wages/salaries other benefits and allowances to his personnel that might become applicable under any Act or Order of the Govt. in this regard, the Service Provider shall indemnify BSNL against any/all claims which may arise under the provisions of various Acts, Government Orders etc. and any breach of such laws or regulations shall be deemed to be breach of this contract.
- (ii) No direct or indirect liability arising out of such negligent, rash and impetuous driving which is an offense under section 29 of IPC and any loss caused to BSNL have to be suitably compensated by Service Provider.
- (iii) Not be responsible for theft, burglary, fire or any mischievous deeds by his staff.
- (iv) Service Provider shall be the employer for his workers and BSNL will not be held responsible fully or partially for any dispute that may arise between the service provider and his workers.
- 13. BSNL reserves the right to place sticker/Flex or any such material deemed fit for advertisement of BSNL product& services without any payment.
- 14. Vehicle can be sent to any place within CG Telecom Circle or BSNL as whole in case of requirement.
- 15. The contractor who participates in tender will be presumed to have agreed that BSNL vehicles, which are basically for operational needs of field units, will have to carry testing instrument, cables, main power and other tools necessary for such purposes. If the driver/contractor disagree at any time to accommodate such requirement will be black listed from participation in future tenders anywhere in BSNL and his current

- contract will be cancelled/ terminated and SD will be forfeited . The bidder is required to give an undertaking in this regard in technical bid as part of bidder's eligibility document as declaration- IV."
- 16. If the vehicle in charge or any representative of CGMT CG CIRCLE Raipur asks the contractor to remove the driver from that vehicle, normally, the driver should not be re- employed in any other vehicle of BSNL Indore but if the contractor requests that due to his professional reasons he has to reemploy this driver in any other vehicle, the driver can be given one chance to show improvement and remain employed in the second vehicle or can be brought back to original vehicle. CGMT CG CIRCLE Raipur reserve sole right to decide on this issue.
- 17. In exceptional cases if the contractor offers, on his own, vehicle of grade higher then mentioned in the tender and if it is in very good condition and is of earlier model, CGMT CG CIRCLE Raipur reserves the right to permit the use of such vehicle at the rate approved in the tender for the original grade of the vehicle.
- 18. One working day will be given for the maintenance in month but one Sunday in lieu of the above will be used for the network operation and maintenance through this vehicle.
- 19. If the vehicle in charge (of any rank) orders the driver to take the vehicle outside his jurisdiction, the driver must inform the contractor who will in turn will take permission from officer who has issued work order. Any such Journey performed without permission will not be payable.

- 7. Service Provider will submit bills in accordance with Clause 4 of Section-IV of the Bid document to concerned Section of BSNL on monthly basis for release of payment by BSNL.
- 8. The driver of the vehicle shall always hold a valid Photo Identity Card issued by local Central / State govt. office competent to issue such cards and also carry duty slips printed by the Service Provider as per the Format prescribed by BSNL, where the date, time, KMs reading, purpose and places visited are to be filled in and signed by the Users / BSNL officials. On the basis of these duty slips, the bills shall be raised to BSNL by the Service Provider. Counting of distance will be from the starting point of the user and closing at the point wherever user completes his / her travel. The distance covered in each way between user delivery address and the garage/ normal parking place will be allowed on actual basis or 5 KMs whichever is less.
- 9. If the Service Provider fails to provide the vehicle to BSNL and if the service is not found satisfactory enough, the BSNL shall have the right to terminate the contract in whole or part as per clause (8) of Section V of Bid Document.
- 10. In the event of any mechanical failure/breakdown of vehicle after it's reporting for duty, the Service Provider shall arrange for replacement by another Commercial Vehicle. Non-compliance may attract penalty as per Clause (9) of Section VIII of Bid Document.
- 11. The following penalties will accrue to the Service Provider in addition to the deduction on hire charges on prorata basis. The penalty amount shall be deducted from the running bills besides any other action which may even lead to termination of contract:-
- 11.1 Non-availability or refusal of vehicles as requisitioned by BSNL for whatsoever reason under this contract shall invite penalty of Rs.500 per occasion.
- 11.2 The penalty for absence during extra Hours. Rs.100 per occasion and for Temporary absence during duty hours without valid permission shall be Rs.75 per hour of absence.
- 11.3 If the vehicle provided by the Service Provider is found to be not in good condition or without proper document; the vehicle may be rejected and sent back. No payment shall be made on account of such rejection. However in case of dispute the decision of THE CGMT CG CIRCLE, would be final.
- 11.4 If the non-availability or refusal of suitable vehicles exceeds three occasions in any particular month, an additional penalty of Rs.300 per occasion shall be charged for the entire refusals.
- 11.5 No payment will be made for vehicles supplied by the Service Provider if the vehicle is older than three years Model or commercially not registered.
- 12. In case of any accident resulting in loss or damage to property of life, the sole responsibility for any legal or financial implication would vest with the Service Provider. BSNL shall have no liability whatsoever.
- 13. The Bid Document No. Dated , schedules annexure/appendix which are annexed to this agreement, as schedule & \_\_\_\_ respectively shall form part and parcel of this Agreement and integral part of this agreement.

- 14. That Service Provider is/shall be liable for any legal dispute/cases/claims that have arisen or may arise during the currency of the agreement in respect of vehicles provided by Service Provider. BSNL shall not be liable for any loss, damages, etc suffered/ to be suffered by Service Provider or third party as the case may be.
- 15. If for any reason the BSNL is dissatisfied in any way with the standard of the vehicle or felt deficiency in service during the hire period, it will be reported to the Service Provider in writing. The Service Provider without raising any dispute on such assessment by the BSNL regarding the standard of the vehicle provided or quality of service rendered by them may immediately replace it with another commercial vehicle on receipt of such complaint.
- 16. The Service Provider shall also be liable for all fines, penalties, and the like of parking, traffic and other criminal offences arising out of or concerning the use of the vehicle during the hire period and any toll Charges or entry Taxes payable locally and the Service Provider accordingly indemnifies the BSNL against all such liability.
- 17. The Service Provider shall not act as a broker for other hire companies or any individual or transfer or assign or sub-let any part of the service once agreed or any share of interest in any manner or degree, directly or indirectly, to any third party whatsoever and the contract will be valid only if the company signing the contract supplies the vehicles themselves from their own or leased fleet.
- 18. The Service Provider will also ensure that they will not supply the vehicles to BSNL which are either owned by employees of BSNL either directly recruited or on deputation to BSNL or their near relatives as defined in Schedule-IA of Company Act 1956 and clause 11. (iii) of Section-VIII of the Bid documents enclosed as schedule to this agreement. A certificate to this effect is annexed to this agreement as **Appendix-IV**.
- 19. The Service Provider will not be tampering the meter reading, vehicle usage timings, overwriting of Summary / log sheet and allow misbehavior of driver while on duty. Such incidents shall be viewed seriously, leading to cancellation of contract.
- 20. Service Provider shall not engage any person below 18 years of age.
- 21. Rates charged by the Service Provider for the services given under this contract shall not be higher than the rates quoted by the Service Provider in his bid and will be regulated by clauses (6 & 7) of Section-V of Bid Document. The revision of rates may be allowed on account of increase or decrease in price of Petrol/Diesel/CNG and these variations shall be worked out from the base rate as per formula indicated in Clause (7.1) of Section-V of Bid Document.
- 22. The KMs not used during a particular month (monthly KMs slab) shall be carried over to the subsequent three months and extra KMs if any travelled during these three months will be adjusted against these unused KMs.
- 23. In the event of any question, dispute or difference arising under the agreement or in connection there with (except as to the matters, the decision to which is specifically provided under this agreement), the same shall be referred to sole arbitration of CGMT,CG Circle of Bharat Sanchar Nigam limited (BSNL) of the respective Circles/District or any other person appointed by him. In case his designation is changed or his office is abolished then in such case to the sole arbitration of the officer for the time being entrusted whether in addition to the function of the CGMT or by whatever designation such officers may be called (hereinafter referred to as the said officer). In the event of such Arbitrator to whom the matter is originally referred to vacates his office on resignation or otherwise or refuses to do work or neglecting his work or being unable to act as Arbitrator for any reasons whatsoever, the CGMT,CG Circle of BSNL shall appoint another person to act as Arbitrator in the place of outgoing Arbitrator and the person so appointed shall be entitled to proceed further with the reference from the stage at which it was left by the predecessor and that the award of the arbitrator shall be final and binding on both the parties. Service Provider will have no objection in any such appointment that arbitrator so appointed is an employee of BSNL or a Government Servant or that he has to deal with the matter to which the agreement relates or that in the course of his duties as a BSNL employee he has expressed his views on all or any of the matters in dispute. The adjudication of such Arbitrator shall be governed by the provisions of the Arbitration and Conciliation Act 1996, or any statutory modification or re-enactment there of or any rules made thereof.
  - The venue of Arbitration proceeding shall be Office of CGMT, CG Circle of BSNL at Khamhardih, Raipur or such other place as the arbitrator may decide.
- 24. If the Service Provider institutes any legal proceedings against the BSNL to enforce any of its rights under this agreement it shall be in the legal jurisdiction of BSNL where the vehicle has been hired and not the place where the Service Provider has his registered office.

- 25. The Service Provider is / shall be responsible for compliance of all the laws / rules/ regulations and Government instructions that are/ will be applicable to and aimed to protect the interest of the Local Traffic Rules/Motor Act/employees/ workers engaged by it and shall ensure payment of all the statutory dues/ liabilities as may have arisen during the past 'or' may arise during the course of performance of this contract.
- 26. Notwithstanding anything contained in the Bid Document, the successful bidder shall have to furnish an unequivocal and unqualified undertaking / declaration to indemnify BSNL in the pro-forma annexed as Appendix –IV dully attested by a Magistrate / Executive Magistrate.
