1.0 Introduction: Bharat Sanchar Nigam Limited (BSNL) is a major telecommunication service provider in India.

1.1 It offers all kinds of telecommunication services like Basic (both fixed and wireless), Cellular, Data, National long distance, Internet etc. Keeping pace with the technological trend to provide latest and varied value added services to its customers, BSNL has Discounted a state of art Multi Protocol Label Switching (MPLS), Virtual Private Network (VPN) network.

1.2 It is implemented over a high capacity (STM-1 expandable up to STM-16 in future) dual layer robust MPLS Network that has inherent redundancies in routing capability guaranteeing specified service levels. The technology enables secure Virtual Private Networks (VPN) to be built and allows scalability that will make it possible for BSNL to offer assured growth to its customers without having to make significant investments.

1.3 BSNL would now be geared to provide Bandwidth on demand, Video Conferencing, Voice over IP (VoIP) and a host of other value added services that could revolutionize the way a corporate business works.

1.4 The basic Objective of this EOI is to enable BSNL to provide complete end-to-end solution to esteemed customers, BSNL intends to have a tie up with System Integrator (SI) who will do all the marketing & Selling of BSNL Data Services & Supply, Configuration and Maintenance of Customer's End Equipments, their network on LAN / WAN etc. for Data Services offered by BSNL. In case required, they will also do all the operations and maintenance activities related to customer end & co-ordination with concerned agencies.

1.5 The BSNL's MPLS VPN Nodes are presently located at approx. 300 places. In addition to this approximately approx 784 districts have been designated as Virtual Nodes. However, the VPN can be

Further details of the MPLS Network capabilities, pricing, Service Level Agreement (SLA) etc. will be shared with the selected SI's.

2.0 Model Eligibility Criterion for Network Integrators

BSNL requires services of System/Network Integrators, who will be responsible to supply network equipment, configuration and integration with existing network, operation, maintenance and support related to customers.

The Network Integrators shall be categorized as National System Integrators/Circle System Integrators/Circle-Silver System Integrators /BA System Integrators. Basic structure and scope would be as below:

2.1 National level Empanelled SIs:

2.1.1 Letter from Concerned BSNL office:

2.1.1.1 SI need to give a letter along with copy of this EOI to concerned BSNL office intimating that against the PBG submitted, they are entering into agreement with CG BSNL circle as per EOI.

2.1.1.2 SI needs to give a letter of authority to concerned BSNL office that PBG Rs. 15 Lakhs for national level SIs can be en-cashed by BSNL on the request of CG BSNL unit and the SI will have no objection for the same.

2.1.2 Agreement as per this EOI will have to be entered and all terms and conditions along with the targets requirement will be applicable.

2.1.3 Since PBG submitted by them with BSNL is being linked to works done in several circles, hence an additional PBG of 5% value of non-BSNL portion of the project will have to be submitted, before award of work. The validity of the PBG will be three months more than the project duration. The Project duration includes warranty and AMC, if any required by the customer.

2.2 **EMD:** EMD of required value for National, Circle level, Circle level-Silver and BA SI in the form of Bank Guarantee from any scheduled bank valid for One year as per proforma attached.

2.3 **EMD Shall be forfeited in case,**

2.3.1 If a bidder withdraws or makes any modifications in the terms and conditions of the EOI before acceptance of the tender, which are not acceptable to the department or

2.3.2 If the successful bidder fails to submit PBG in prescribed format with in 3 to 4 weeks after approval of empanelment / issue of LOI.

Performance Bank Guarantee (PBG): The PBG amount is Rs. 15 Lakhs, 3 Lakhs, 50 Thousand and 25 Thousand for National, Circle level, Circle-Silver and BA SIs respectively.. The Bank Guarantee submitted against EMD will be returned after submission of PBG.

3.0 Terms and conditions:

- 3.1 The SI policy is non-exclusive, walk-in and open for all eligible categories.
- 3.2 It is a Non-exclusive agreement.
- 3.3 The System Integrator is free to develop their network in Circle either directly or through partners for marketing. The Agreement shall not restrict BSNL from contracting for identical or similar services from any other person / party.
- 3.4 BSNL will engage SI for marketing & selling of BSNL Data Services & Supply, Configuration and Maintenance of Customer's End Equipments, their network on LAN / WAN etc. for Data Services for BSNL customers.
- 3.5 The short-listed SI's need to sign an agreement with BSNL as per format specified in Annexure-C.
- 3.6 The short-listed SI's need to submit the Performance Bank Guarantee in time as per format specified in Annexure B. Normally the **time period is 3 to 4 weeks.**
- 3.7 BSNL and SI will jointly address the network requirements of the customer along with any other services required by the customer.
- 3.8 SI's will adhere to SLA, which BSNL has offered to its customers.
- 3.9 For providing last mile connectivity to the customer, SI will coordinate and pursue with concerned BSNL authorities as well as other agencies / Departments (Like MTNL, regional offices of BSNL) to enable the same and complete the project in time. Additional Discount as mentioned in Discount structure is payable for the project completed in time.
- 3.10 SI will also conduct technical seminar for BSNL Officers to make them conversant about their product capabilities vis-à-vis customer requirement.
- 3.11 SI will also provide relevant equipment free of cost for demonstrating the capability of VPN, if the same is required by the customer. As a mobilizing charges Rs 5000/- per site per month will be paid to SI for arranging equipment for demonstration. If any BSNL resource is required, then the same will be provided free of cost. .

- 3.12** Tie-ups for extending the services nationally and internationally will be permitted.
- 3.13** SI will also conduct Enterprise Customer meet / other promotional events for generating business / creating awareness about BSNL products and services in consultation of BSNL. 50% of the estimated expenditure of the meeting can be borne by BSNL.
- 3.14** For the customers serviced through National Level SI, the SI shall provide to BSNL 24 hrs, 7 days a week helpdesk, either web based or call center. The booking of complaint to SI can be made by customer, BSNL NOC/Call Center/Node. For emergency case specifically for situation where critical node is down, SI shall ensure that the consultation, assistance and advice within four hours or as defined in SLA entered with the customer. In other cases, the complaint must be attended within eight hours. For the customers serviced through Circle level SI, the SI shall provide to BSNL 24 hrs, 7 days a week helpdesk, either web based or call center directly or indirectly through offered services of OEM. The booking of complaint to SI can be made by customer, BSNL NOC/Call Center/Node (For Circle Level SI in CG Circle Only).
- 3.15** SI shall supply spares directly or through back end tie up with the Original equipment manufacturer to address any equipment related problem within 12 hours in the same city and within 48 hours for outstation site.
- 3.16** The Discount structure can be changed or the Discount can be removed / altered / augmented as per market conditions or BSNL policy. The decision of BSNL in this regard will be final and binding.
- 3.17** SI's are supposed to meet the minimum targets as mentioned in targets achievement clause. BSNL reserves the right to revise the targets based on mutual discussions. Non-meeting the targets for two quarters will be treated as non-performance. BSNL will be free to take action as deemed fit including termination of System Integrator.
- 3.18** The SI's need to mention the make of the equipments which he will be supplying. Though exact requirements will be as per customers request yet the general technical specification of the Customer's End Equipments, their network on LAN / WAN etc. is attached at Annexure-A for information.

- 3.19 Whenever any SI's proposes to supply equipments from any new vendor then the System Integrator should provide letters of support from that OEM (Original equipment manufacturer) stating that their products / solution as proposed by SI, will be supported for at least next three years, extendable to seven years.
- 3.20 SI will also help Key Account managers.
- 3.21 The present range of services along with Discount structure will be informed later.
- 3.22 Empanelled SI can also be engaged by the CGM Telecom Circles / Telecom Districts / Regions for providing support to customers, for which additional incentive mutually agreed between SI and the CGM concerned will be worked out. This will be based on the quality and quantum of support envisaged. This is to ensure customer friendly pre and post one point after sales services to the customers.
- 3.23 SI will use their own distribution network. The area of operation will be across the country.
- 3.24 The terms and conditions of the Agreement are subject to modification by mutual agreement based upon the request of either party. In case of no agreement being reached in such cases, BSNL reserves the right to terminate the agreement as per the provisions of this agreement.
- 3.25 The Commissioning of VPN will be the responsibility of SI. The hardware and services required for Commissioning of VPN must be made available as per schedule given in PO. Normally the Commissioning of the project will be **within twelve weeks** from the date of Advance Purchase Order or as per customer requirements.
- 3.26 SI will depute appropriate resources to monitor and manage the progress of the project.
- 3.27 SI should give on site warranty of twelve months from the date of Commissioning of VPN. Warranty cost will be included in the cost of equipment. For any unforeseen delays not due to customer / BSNL reasons the warranty will be limited to 12 months after Commissioning or 15 months from the date of delivery of equipment at site, which ever is earlier. After warranty support, SI should also provide the AMC of the Customer's End Equipments, their network on LAN / WAN etc. for minimum additional two years extendable to six years beyond the warranty.

- 3.28** In case of BSNL being lead bidder and the terms and conditions required by customers are different and stringent then the terms and conditions as required by customers would override the standard conditions of this EOI. Customer's conditions will have to be satisfied on back to back basis. The decision of BSNL will be final and binding.
- 3.29** SI shall provide maintenance and support services to BSNL in respect of the Equipment for new customer sales.
- 3.30** SI shall carry out quarterly preventive visit to each VPN site, if the equipments are under warranty or AMC with the SI.
- 3.31** Any sum of money due and payable to the SI shall be appropriated by BSNL and the same may be set off against any claim of BSNL for payment of a sum of money arising out of this Agreement or under any other Agreement / contract made by the SI with BSNL.
- 3.32** The liability to insure the merchandise, if any, in the outlet(s) and in the possession of the SI will be of the SI and the liability for any loss or damage due to any fire, burglary, theft, etc. will be that of the SI.
- 3.33** The SI shall be fully responsible for the employment or payment of wages to its employees and shall fully comply with all laws, rules, regulations, notifications, directions orders etc. of the Govt. whether Central, State, Local or Municipal relating to such employment, payment of wages etc. and all others matter connected therewith and hereby indemnifies and agrees to continue indemnifying BSNL in this regard.
- 3.34** In the event of termination of this agreement consequent upon breach of any of the terms of this agreement by SI, or if SI fails to perform / execute the contract, SI shall be debarred by BSNL for a period of 3 years for all future dealings with BSNL.
- 3.35** A connection from CDR System (Leased Line provisioning and billing System of BSNL) / any other IT system will be extended with viewing / Demand note issuing rights for the customers booked by them and initial booking of demand and subsequent issue of demand note. The computer /modem etc will be arranged by SI and the access over dial up/VPN over broadband/Any other method will be supplied by BSNL free of cost.

- 3.36 As per approved tariff plan the System Integrator as SI can issue subsequently demand note etc. on behalf of BSNL after checking feasibility from concerned nodal officers of BSNL CDR system.
- 3.37 The customer can pay either directly to BSNL or through SI by cheque / DD drawn in the name of BSNL. In case the customer is paying to SI, then SI will intimate the nodal officer latest by the next working day along with deposit of the cheque / DD collected.
- 3.38 The BSNL shall have no liability or obligation for any State or Local Govt. Levies / Taxes for providing services by SI under this Agreement.
- 3.39 **OBLIGATIONS OF BSNL:** BSNL shall solely at its discretion promote the High End Services under this Agreement. The expenses for the promotion campaign and the extent and scope of such media advertisements etc. shall be at the sole discretion of the BSNL and the **SYSTEM INTEGRATOR AS SI** shall not have any role assigned in that. The **SYSTEM INTEGRATOR AS** shall duly follow the policies and directives of the BSNL in the marketing, promotion and advertising of the Services.
- 3.40 The **charges and other tariff charges** by the BSNL for the Services are the sole prerogative of the BSNL and the **SYSTEM INTEGRATOR AS** shall not represent to subscribers any charges other than those as prescribed by the BSNL for subscription to the Services. Normally the standard tariff along with any bulk booking discounts are available on the official web site of BSNL corporate office and the same can be taken as BSNL offered prices by the System Integrator for marketing and selling of the services. Over and above, BSNL shall inform the **SYSTEM INTEGRATOR** of any other charges and tariff changes to facilitate him to conduct the business on behalf of BSNL.
- 3.41 In case of competitive tariff from the competitor and / or any specific requirement of the customer the System Integrator will bring it to the notice of nodal officer for necessary decision. As per the decision further action will be taken by the System Integrator.
- 3.42 The specific decisions so taken by the BSNL is for a particular case only and the System Integrator is not authorized to quote the same to other parties unless and until the same has been authorized by BSNL.

- 3.43** BSNL shall provide certain benefits to the **SYSTEM INTEGRATOR** during the tenure of this Agreement as per the policies of BSNL which shall be announced and intimated to the **SYSTEM INTEGRATOR** from time to time. However in case the **SYSTEM INTEGRATOR** starts dealing in promotion and marketing of services of any competitor of BSNL or this agreement is terminated for any reason whatsoever, the BSNL shall forthwith withdraw the aforesaid benefits.
- 3.44** SI can do the publicity/ exhibitions / conferences for promotions. The format as well as content along with estimated expenditure will be pre-approved by BSNL. 50% of estimated expenditure will be reimbursed by BSNL.
- 3.45** BSNL reserves the right to appoint any number of System Integrator in this category or sell directly or through other channels also. BSNL also reserves the right to create other categories of System Integrator to serve a particular segment of customers. The Data segment market is growing at a very high pace and each SI's appointed through this EOI will have to meet targets as specified.
- 3.46** BSNL reserves the right to engage SI on mutual terms and conditions for various support systems as agreed between the parties for improving the customer confidence, for providing support, either fully or partially. Additional incentive may be considered by BSNL on mutual consent basis based on the quality and quantum of support system envisaged.
- 3.46.1** One window interface for all its requirements for provisioning, operation and after sales services.
- 3.46.2** Fast provisioning of the services.
- 3.46.3** Reliable quality services during operations.
- 3.46.4** In case of fault, attending the same with in reasonable period of time and with desired promptness.
- 3.46.5** For providing improved SLA to customers.
- 3.47** Delivery of equipments purchased through SI for the customers as per customers requirements will be SI's responsibility at their cost. They are supposed to transfer the equipments from the place of supply to their local office and then supply the equipments locally to customers under proper receipt. Timely supply is SI's responsibility.

4.0 Scope of the Work:

- 4.1** BSNL intends to capture a sizeable portion of growing data market. To achieve it and to provide complete solution in a strict time frame, empanelment of eligible System Integrators are proposed to be done.
- 4.2** The System Integrator shall do marketing & selling of BSNL Data Services & Supply, Configuration and Maintenance of Customer's End Equipments, their network on LAN / WAN etc. for Data Services for BSNL customers. The list of services viz. Internet Leased Lines/ Leased Lines/ MPLS VPN/ Broadband VPN/ IP VPN/ Server Co-location/ Any other Services with discount structure.
- 4.3** The System Integrator can use logo and name of BSNL for selling BSNL DATA SERVICES during contract period.
- 4.4** The modus-operandi of various types of possible sales is as mentioned below. Now a day's customer desires to have a complete solution from the service Provider, which includes the customer's requirements. The possible customer requirements have also been explained below. The provisioning of customers requirements, if required by customer will also be dealt as per the procedure explained in types of possible sales. The Discount on sale of BSNL services, wherever applicable has also been mentioned.

4.5 Types of Possible Sales:

- a) It is appreciated that, on-Boarding of customer, on nomination basis is most difficult and an important step in Enterprise Business Chain. Though BSNL is having its own Sales Teams and mechanism but the help of SIs is very crucial as they are domain knowledge experts. BSNL encourage SIs to bring on board more and more customers on behalf of BSNL. SI who makes all efforts in On-boarding the customer will be extended all out support and will not be subjected to undue competition.
- b) But it is also a fact that most of the business on nomination comes out of customer's faith in the fair and transparent policies of BSNL at large. It becomes more important when the end customer is Government or its subsidiary and awards work to BSNL on nomination basis, BSNL itself being a Govt.

So, with a larger business interest in view, the policy of “Bring It Get It” on back to back basis will only be adopted in rare cases where the client gives clear choice for a particular SI, with its rates and the solution. Otherwise, the prevalent practice of exploring best rates from empanelled vendors/SIs by the Circle Standing Committee will continue.

- c) However, the efforts of SI can't be undermined in bringing the customer on board may it be a Government or Private and involves continuous visits presentations and perusals at different levels and to appreciate the same and in order to give an edge to such SIs (Incumbent SI), who nurtured the business, will be given a choice if he is eligible and can meet the competition by way of providing “First Right of Refusal” at the L1 rates, determined by Limited e-Tendering method from the eligible sources
- d) In case the incumbent SI is non L1 and chooses not to accept L1 rates, the L1 SI/Vendor has to work on his quoted rates. In case L1 SI/Vendor refuses to work, then he shall be debarred for one year to participate in tender from date of refusal, along with other penal actions under empanelment.
- e) The genuineness of rates however would continue to be vouched by the Circle Standing Committee.

4.5.1 Lead Bidder: SI

4.5.1.1 Customer will mention in writing that the case has been processed through SI either through a letter on their letter head or by endorsing on the form itself.

4.5.1.2 BSNL is only responsible for BSNL portion of services.

4.5.1.3 For Customers requirements of non-BSNL products / services, the SI is directly dealing with the party and receiving the payment. BSNL is not coming in picture, hence is not responsible for the same.

4.5.1.4 Discount on BSNL portion of services will be

payable. Coordination and speedy implementation of the project is a part of the job and no additional Discount will be paid for the same.

4.5.1.5 Project completion in time Incentive is applicable.

4.5.2 **Lead Bidder: BSNL – Without Tender – Customer mention in writing that case has been processed through SI.**

4.5.2.1 Quotation from the SIs will be taken and the same will be quoted to party after taking relevant taxes into consideration.

4.5.2.2 The SI will furnish a certificate to BSNL that the charges made to customers for Customer's requirement are fair and reasonable.

4.5.2.3 BSNL administrative charges will be applicable, while paying back to SI, for the equipments / services of customer's requirement portion.

4.5.2.4 Discounts will be payable for BSNL portion of the project. Coordination and speedy implementation of the project is a part of the job and no additional Discount will be paid for the same.

4.5.2.5 Project completion in time Incentive is applicable.

4.5.3 **Lead Bidder: BSNL – Without Tender – Customer does not mention in writing that case has been processed through SI**

4.5.3.1 Case will be dealt as per procedure given for the case, where BSNL will participate in tender. The same is mentioned below:

4.5.4 **Lead Bidder: BSNL – By Tender / Competitive bidding process**

4.5.4.1 Limited enquiry among the panel of SI's of CG Telecom Circle will be called for as per the customer requirement.

4.5.4.2 BSNL will quote the rates as per the market

conditions, keeping in consideration the rates quoted by L1 bidder. The L1 bidder will be awarded the work.

4.5.4.3 Once payment is received it will be given back to the party as per payment terms / PO conditions.

4.5.4.4 No Discount structure on BSNL portion of Bandwidth will be applicable.

4.5.4.5 Coordination and speedy implementation incentive will be applicable.

4.5.4.6 Project completion in time Incentive is applicable.

4.6 **Customer Requirements:** The possible requirements other than the BSNL services could be as follows. It is just an illustrative list and not the exhaustive one. The guiding principle us anything asked by customers is customers requirement.

4.6.1 All equipments / services / IT integration asked by the customer apart from BSNL data services.

4.6.2 At times customer wants the equipments and services to have on Lease. In such cases the investments will be done by SI, if they so like. Back to back payment will be done after deducting BSNL non-refundable charges. The SI's willing to supply equipments on lease will be maintained separately and quotation from such cases will only be asked from such SI's.

4.6.3 (a) Many a times the customer wants to have back up link on RF / VSAT/ISDN/CDMA/3G the same can also be dealt as per the procedure mentioned above, as the main intention is to provide total solution to the customer.

(b) In case the equipments/solutions needed by the customer are available with BSNL then the same will be supplied unless and until the same is refused by the customer due to compatibility or any other issues.

4.7 The SI is supposed to bring business for BSNL, where SI is front bidder or if BSNL is front bidder, then customers have identified that the business has been generated by SI. Direct Marketing of services needs to be done by SI. The target achievement clause as mentioned in this EOI is for the business generated from these

types of sales only and for the BSNL portion of the project. For all other categories of sales SI will proactively apprise and coordinate with BSNL in preparation of bid documents as well as in securing business.

4.7.1 For Direct Marketing of services as mentioned above, the SI shall be responsible for marketing and selling the BSNL DATA SERVICES at his own cost and risk. BSNL shall be under no obligation to market and advertise the services defined under this Agreement, though BSNL may do of his own.

4.7.2 The SI may make / use his / their own distribution sale network / methods. The expenses for the selling campaign(s) and use of sales teams/methods, etc. shall be at the discretion of the SI. As per competition and market condition they will regularly apprise BSNL and will help BSNL in giving a best deal to customer, so that business expands.

4.8 TARGETS Achievement:

4.8.1 The minimum annual targets for each SI is to bring business worth at least Rs 1 crore / annum from only BSNL portion of the projects brought in by them through the type of sale mentioned in clauses 4.5.1 and 4.5.2

4.8.1.1 Though the target set is for per annum basis and from all the services viz. Internet Leased Lines/ Leased Line/ MPLS VPN/ Broadband VPN/ IP VPN/ Server Co-location/ Any other services as decided by CGM CG Telecom Circle, yet efforts to be made to achieve targets quarterly on proportionate basis.

4.8.1.2 All due revenue from the customer must be collected in time.

4.8.1.3 The target set is not linked with actual revenue collection. If customer has selected quarterly plan to submit bills, then actual bill collection will be only as per schedule, but for target calculation the whole annum revenue will be taken into account.

- 4.8.1.4** Discount will be payable on applicable cases only for the portion of payments done.
- 4.8.2** The business generated by SI is either as a lead bidder or if BSNL is a lead bidder then by direct approach and where the customer has identified that case has been processed through SI.
- 4.8.3** Quarterly, CGM **BSNL**, or his authorized representative will review with the **SYSTEM INTEGRATOR** minimum targets for the **High End** Services, taking into account the market development and market potential and other relevant factors. The achievements of these prescribed targets by the **SYSTEM INTEGRATOR** will be a material obligation of the **SYSTEM INTEGRATOR** under this Agreement. However, the target such fixed will be achievable and realistic.
- 4.8.4** If, in the opinion of **BSNL**, the **SYSTEM INTEGRATOR** is at any time not adequately meeting the targets for the High End Services, then without prejudice to any of its other rights under this Agreement, **BSNL** may, at its option vary this Agreement, so as to exclude, reduce, modify, suspend the assignments and obligations of the **SYSTEM INTEGRATOR** under this Agreement or terminate this Agreement.
- 4.8.5** **BSNL** and the **SYSTEM INTEGRATOR** agree to review the service turnover on monthly/quarterly basis at the discretion of BSNL and **BSNL** shall advise the **SYSTEM INTEGRATOR** in writing of any shortfall in the targets for subscription to the High End Services and the **SYSTEM INTEGRATOR** shall furnish in writing its explanation for such shortfall.

5.0 Payment Terms:

- 5.1** The incentives payable shall be as per BSNL policy.
- 5.2** The customer will make all payment including cost of bandwidth and Customer's End Equipments, their network on LAN / WAN etc. to BSNL (either in lump sum or in installment as the case may be).
- 5.3** Back to back payment arrangement will be there from BSNL

to SI for supply, configuration and maintenance of Customer's End Equipments, their network on LAN / WAN etc.

- 5.4 For each project as per the customers requirement, BSNL will issue a PO for non-BSNL portion to SI containing details of products/services along with approved price, terms and conditions of the same.
- 5.5 90% payment will be made on delivery, installation and acceptance of the same from the customer and balance 10% after satisfactory working of the same for a period of three months from the date of Commissioning, after receipt of payment from the customer.
- 5.6 The AMC payment, wherever entered will be made quarterly and after the expiry of quarter subject to fulfillment of SLA and maintenance schedule.
- 5.7 Discount on BSNL portion of the project, wherever applicable will be paid after Commissioning of the project and payment by the customer. Payment will be done monthly / quarterly / half yearly / annually after payment is received from customer.

5.8 **Penalty Clause:**

5.8.1 **Delayed Supply:** Any delay in supply of equipment shall attract liquidated damages (LD) @ 0.5% of the total value of the delayed supplied equipment for a delay of every week or part thereof for the first three weeks and @ 0.7% per week thereafter, subject to maximum LD of 5% of the total value of the delayed equipment.

5.8.2 **Delayed Commissioning:** The commissioning of total network including supply of the equipment is to be completed **as per PO from the date of receipt of PO to SI**. A penalty at the rate of 0.5% of the cost of hardware and bandwidth charges of the location not completed shall be payable per week of delay or part thereof subject to a maximum of 5% for that site. If the delay is more than two weeks, then BSNL shall have the right to terminate the project with a penalty of 5% of total work order cost and get the work done at the cost and risk of the SI from any other vendor.

5.8.3 If any project is having other than the above mentioned penalty clauses and is more stringent then the same will

be applicable and it will be mentioned in the PO.

5.9 Non-adherence to SLA, which BSNL has committed to customer: BSNL may also deduct the amount at actual which BSNL needs to pay to customer on account of non-adherence to SLA / PO (Service Level Agreement / Purchase Order), from SI's balance payment or security deposits, if due to failure on the part of SI's, BSNL could not meet the SLA/PO conditions.

5.10 Without prejudice to its rights and any other remedy, BSNL may en-cash PBG in case of any breach of terms and conditions of the agreement or in case of business loss suffered by BSNL due to failure of service on the part of SI.

6.0 Empanelled SI's utilization by Telecom Circles:

6.1 Circle / SSA / Any other BSNL units can use fully the empanelled SI's by CG Telecom Circle through this EOI.

6.2 While awarding work to SI the Concerned circle / SSA / any other BSNL units will take a PBG of 5% value of non-BSNL portion of the project, before award of work. The validity of the PBG will be three months more than the project duration. The Project duration includes warranty and AMC, if any required by the customer.

6.3 As per customers request the case can be booked by SI's in respective SSA/Circle under intimation to nodal officer in CG Telecom Circle.

6.3.1 The System Integrator will submit along with the bills:

6.3.1.1 Xerox copy of the paid demand note.

6.3.1.2 Payment particulars.

6.3.1.3 Payment mode – Monthly / quarterly / annually / any other.

6.3.1.4 Certificate from the customer, regarding circuits made operational. Based on the customer acknowledgement of circuits made operational the billing will start.

6.4 Payment will be normally made to SI's within 3 weeks from the date of the submission of the bills.

6.5 SSA / Circle will release the Discount to SI under intimation to nodal officer in CG Telecom Circle after receipt of payment from the customer.

7.0 AGREEMENT:

7.1 Duration of Agreement: This agreement shall be valid for a period of **FIVE YEARS** from the date of signing the Agreement unless revoked earlier for whatever reasons. If at any stage during the tenure of this agreement, it comes to the notice of BSNL, directly or through some other complaint, that the System Integrator had misrepresented the facts or submitted any false information or hidden any information, which could have affected the signing of this agreement with the System Integrator this agreement shall stand terminated immediately under intimation to the System Integrator.

7.2 Extension of Agreement:

7.2.1 BSNL may extend, if deemed expedient, the period of agreement by TWO YEAR at one time, suo moto or in mutual agreement with the System Integrator on mutually agreed terms. Further extensions in terms of one year will be given on request of the SI, based on their performance. The decision of BSNL shall be final in regard to the grant of extension.

7.2.2 After the expiry of initial agreement period of one year, BSNL reserves the right to refuse the request for extension, modify some/ all the clauses of the agreement.

7.3 Restrictions on 'Transfer of agreement': The System Integrator shall not assign or transfer its right in any manner whatsoever under this agreement to a third party or enter into any agreement for sub-contracting and/or partnership relating to any subject matter of the agreement to any third party either in whole or in any part i.e. no sub-contracting/ partnership/ third party interest shall be created.

7.4 Liability: Except as provided in this Agreement, hereinabove, neither party shall be liable to other party or any other party by virtue of termination of this Agreement for any reason whatsoever for any claim for loss or profit or on account for any expenditure, investment, leases, capital improvements or any other

commitments made by the other party in connection with their business made in reliance upon or by virtue of this Agreement.

7.5 Suspension, Revocation or Termination of agreement:

7.5.1 BSNL reserves the right to suspend the operation of this agreement, at any time, due to change in its own license conditions or upon directions from the competent government authorities. In such a situation, BSNL shall not be responsible for any damage or loss caused or arisen out of aforesaid action. Further, the suspension of the agreement will not be a cause or ground for extension of the period of the agreement and suspension period will be taken as period spent. During this period, no charges for use of the facility of the System Integrator shall be payable by BSNL.

7.5.2 BSNL may, without prejudice to any other remedy available for the breach of any conditions of agreement, by a written notice of Three month issued to the System Integrator at its registered office, terminate / or suspend this agreement under any of the following circumstances:

7.5.2.1 The System Integrator failing to perform any obligation(s) under the agreement;

7.5.2.2 The System Integrator failing to rectify, within the time prescribed, any defect as may be pointed out by BSNL.

7.5.2.3 Non adherence to SLA which BSNL has committed to customer.

7.5.2.4 The System Integrator going into liquidation or ordered to be wound up by competent authority.

7.5.2.5 EITHER PARTY may terminate the agreement, by giving notice of at least Three month in advance. The effective date of surrender of agreement will be three month counted from the date of receipt of such notice by the other party or the authority that signed the agreement on behalf of other party.

7.5.2.6 If the System Integrator is wound up or goes into liquidation, it shall immediately (and not more

than a week) inform about occurrence of such event to BSNL in writing. In that case, the written notice period can be modified by BSNL as deemed fit under the circumstances.

BSNL may either decide to issue a termination notice or to continue the agreement by suitably modifying the conditions, as it feels fit under the circumstances.

7.5.2.7 It shall be the responsibility of the System Integrator to maintain the agreed Quality of Service, even during the period when the notice for surrender/termination of agreement is pending and if the Quality of Performance of Solution is not maintained, during the said notice period, it shall be treated as material breach liable for termination at risk and consequent of System Integrator and Performance Bank Guarantee shall be forfeited, without any further notice.

7.5.2.8 Breach of non-fulfillment of Agreement conditions may come to the notice of BSNL through complaints or as a result of the regular monitoring. Wherever considered appropriate BSNL may conduct an inquiry either suo-moto or on complaint to determine whether there has been any breach in compliance of the terms and conditions of the agreement by the System Integrator or not? The System Integrator shall extend all reasonable facilities and shall endeavor to remove the hindrance of every type upon such inquiry.

7.6 Actions pursuant to Termination of Agreement:

Notwithstanding any other rights and remedies provided elsewhere in the agreement, upon termination of this agreement.

7.6.1 Neither Party shall represent the Other Party in any of its dealings.

7.6.2 Neither Party shall intentionally nor otherwise commit any act(s) as would keep a third party to believe that the other Party is still the former Party's service provider, as

the case may be.

7.6.3 Each party shall stop using the other Party's name, trademark, etc., in any audio or visual form.

7.6.4 The expiration or termination of the Agreement for any reason whatsoever shall not effect any obligation of either Party having accrued under the Agreement prior to the expiration or termination of the Agreement and such expiration or termination shall be without prejudice to any liabilities of either Party to the other Party existing at the date of expiration or termination of the Agreement.

7.7 Dispute Settlement:

7.7.1 In the event of any question, dispute or difference arising under this agreement or in connection there-with (except as to the matters, the decision to which is specifically provided under this agreement), the same shall be referred to the sole arbitration of the CGM CG Circle, BSNL. The agreement to appoint an arbitrator will be in accordance with the Arbitration and Conciliation Act 1996.

7.7.2 There will be no objection to any such appointment on the ground that the arbitrator is a BSNL Servant or that he has to deal with the matter to which the agreement relates or that in the course of his duties as a BSNL servant he has expressed his views on all or any of the matters in dispute. The award of the arbitrator shall be final and binding on both the parties to the agreement. In the event of such an arbitrator to whom the matter is originally referred, being transferred or vacating his office or being unable to act for any reason whatsoever, the CGM CG Circle, BSNL or the said officer shall appoint another person to act as an arbitrator in accordance with terms of the agreement and the person so appointed shall be entitled to proceed from the stage at which it was left out by his predecessors.

7.7.3 The arbitrator may from time to time with the consent of both the parties enlarge the time frame for making and publishing the award. Subject to the aforesaid, Arbitration and Conciliation Act, 1996 and the rules

made there under, any modification thereof for the time being in force shall be deemed to apply to the arbitration proceeding under this clause.

7.7.4 The venue of the arbitration proceeding shall be the office as decided by CGM, CG Telecom BSNL, or such other places as the arbitrator may decide.

8.0 Performance Bank Guarantee:

8.1 Each empanelled SI's will need to submit Performance Bank Guarantee (PBG) subject to minimum of Rs. 15 Lakhs, 3 Lakhs, 50 Thousand and 25 Thousand for National, Circle level, Circle level-silver and BA SIs respectively, before signing the agreement and submission of proposal to the customer, for ensuring full compliance of agreement conditions. Initially, the **PBGs shall be valid for at least Five years and six months** from the date of signing of agreement (effective date) of the service and shall be renewed from time to time till the expiry of agreement and till all outstanding dues to BSNL, if any, have been fully paid and its claims are satisfied or discharged and also discharge of all responsibilities with regard to supply, configure and maintenance of customer end equipment for the full period of warranty / AMC as applicable. The validity of the PBG will be three months more than the project duration. The Project duration includes warranty and AMC, if any required by the customer.

8.2 Amount of PBG shall be reviewed at the end of the first year and thereafter on yearly basis. After the first year PBG shall be 5% of total payment received by the SI from BSNL in the previous year or bank guarantee prescribed above, whichever is higher. The bank guarantee for the difference of additional amount (if any) be paid by the SI **within 30 days** of the start of the New Financial Year. Any failure to do so, shall amount to violation of the terms of the agreement and entitle BSNL to encash the bank guarantee and to convert into a cash security without any reference to the SI and his risk and cost. No interest or compensation whatsoever shall be payable by BSNL on such encashment.

8.3 System Integrator shall also submit additional PBG of at least 5% of the P.O. value, whenever a work is awarded to System Integrator valid for the duration three months more of the project duration. The Project duration includes warranty and AMC, if any

required by the customer.

9.0 Force- Majeure: If at any time, during the continuance of this agreement, the performance in whole or in part, by either party, of any obligation under this is prevented or delayed, by reason of war, or hostility, acts of the public enemy, civic commotion, sabotage, Act of State or direction from Statutory Authority, explosion, epidemic, quarantine restriction, strikes and lockouts (as are not limited to the establishments and facilities of the System Integrator), fire, floods, natural calamities or any act of God (hereinafter referred to as **event**), provided notice of happenings of any such event is given by the affected party to the other, within 21 Calendar days from the date of occurrence thereof, neither party shall, by reason of such event, be entitled to terminate the agreement, nor shall either party have any such claims for damages against the other, in respect of such non-performance or delay in performance. Provided Service under the agreement shall be resumed as soon as practicable, after such event comes to an end or ceases to exist. The decision of BSNL as to whether the service may be so resumed (and the time frame within which the service may be resumed) or not, shall be final and conclusive. However, the Force-majeure events noted above will not in any way cause extension in the period of the agreement.

10.0 CONFIDENTIALITY OF INFORMATION & INTELLECTUAL PROPERTY:

10.1 Subject to conditions contained in this Agreement, the System Integrator shall take all necessary steps to safeguard the privacy and confidentiality of any information about BSNL and its subscribers from whom it has acquired such information by virtue of the Service provided and shall use its best endeavors to secure that:

10.1.1 No person acting on behalf of the System Integrator or the System Integrator himself divulges or uses any such information except as may be necessary in the course of marketing of BSNL DATA SERVICES

10.1.2 No person seeks such information other than is necessary for the purpose of marketing of BSNL DATA SERVICES as mentioned in the “Scope of Work”.

10.1.3 Provided, the above para shall not apply where BSNL has consented in writing to such information being

divulged or used and such information is divulged or used in accordance with the terms of that consent; or the information is already open to the public.

10.2 The System Integrator shall take necessary steps to ensure that the System Integrator himself / herself and any person(s) acting on its behalf observe confidentiality of customer information.

10.3 The System Integrator shall, prior to commencement of this agreement, confirm in writing to BSNL that The System Integrator has taken all necessary steps to ensure that it and its employees shall observe confidentiality of customer information.

10.4 This clause shall survive the termination or expiry of this Agreement.

10.5 Intellectual Property:

10.5.1 The intellectual property rights of the solution offered to and implemented by BSNL shall be with the purchaser. All documents, raw data, research, processes, technology, film, artwork, engravings, dies, paper tapes, magnetic media, programs, designs and inventions (collectively referred to as the “information”) conceived of, collected, completed or produced in the course of performance of the contract by the System Integrator, for BSNL or provided to the System Integrator by BSNL shall be the exclusive property of BSNL and shall be kept confidential.
